Busking Permit Conditions:

1. Busking in any one area for periods exceeding one hour is not permitted unless agreement is obtained from surrounding premises or a specific exemption applies.
2. Buskers using loud instruments (eg, bag pipes or drums) must obtain permission from surrounding premises. Please note this is not a license to create excessive noise.
3. Busking is only permitted between the hours of:  
Sunday to Thursday 9am and 10pm.  
Friday and Saturday 9am and 12 midnight.
4. If the DCC receives justified noise or obstruction complaints relating to the activities of a busker the permit holder will be asked to move on. Failure to comply with such a request may result in seizure of the instrument(s) as provided for under the Resource Management Act.
5. The use of amplifiers is prohibited.
6. Busking on private property is not permitted unless you have the permission of the property owner/tenant.
7. Permits will not be issued to anyone under the age of 14 years without the consent of a parent or caregiver. Proof of age may be requested.
8. The maximum number in any one group is four unless a specific exemption is provided.
9. Permits are valid for a maximum of one year from the date of issue.
10. Buskers must carry their busking permit and show it to Council Officers on request.
11. Buskers must comply with all other relevant Dunedin City Council rules and bylaws.
12. Failure to observe the conditions of the Busking Permit may result in the cancellation of the permit by an officer of the DCC.
