This Dunedin City Council (DCC) service is for residents who unavoidably produce more medical waste than will fit their property's 140L DCC red-lidded rubbish bin collected once every two weeks. The service offers one additional DCC 140L rubbish bin. The additional bin will also be collected once every two weeks on the same day as the property's existing 140L red-lidded rubbish bin. If you would like to use this service, please complete this application form.

There is no additional rates charge or fee for the additional red-lidded rubbish bin and its collection. Because this is a free, extra service, verification that this extra service is required must be obtained from a medical practitioner/medical practice manager/community nurse/pharmacist/Justice of the Peace.

(This service is only available for households on DCC kerbside collection routes. It is not available in the Central Dunedin central business district).
