 - 1.1 The appeal dated 19 December 2018 by KiwiRail Holdings Limited from the Dunedin City Council's ("DCC") decisions on its Proposed Dunedin City District Plan ("2GP").
- 2 The Otago Regional Council is:
 - 2.1 A local authority;
 - 2.2 A person who made a submission on setbacks from waterbodies.
