

MINUTE EXTRACT FROM THE NON-PUBLIC MINUTES OF THE COUNCIL MEETING HELD ON TUESDAY 28 MAY 2019

C1 NEW ZEALAND MASTERS GAMES APPOINTMENT OF TRUSTEES

Councillor Newell withdrew from this item.

A report from Community and Planning advised that the Dunedin (New Zealand) Masters Games Trust Deed required the Council to approve, by resolution, the appointment of new Trustees.

The report noted that the following resignation of Trustee Ron Mackersy, the Dunedin (New Zealand) Masters Games Trust sought approval to appoint two new Trustees; Julie Ryan and John Guthrie. The appointment of new Trustees, while not required under the Trust Deed, supported the Board to enhance its skill base and contributes to the Board's direction of sustainability and growth.

The General Manager City Services (Sandy Graham), Manager Events and Community Development (Joy Gunn) and Masters Games Manager (Vicki Kestila) spoke to the report and responded to questions.

EXECUTIVE SUMMARY

The Dunedin (New Zealand) Masters Games Trust Deed requires the Council to approve, by resolution, the appointment of new Trustees.

With the resignation of Trustee Ron Mackersy, the Dunedin (New Zealand) Masters Games Trust is seeking Council approval to appoint two new Trustees; Julie Ryan and John Guthrie. The appointment of new Trustees, while not required under the Trust Deed, supports the Board to enhance its skill base and contributes to the Board's direction of sustainability and growth.

RECOMMENDATIONS

That the Council:

- a) **Approves** the appointment of Julie Ryan as a Trustee on the Dunedin (New Zealand) Masters Games Board.
- b) **Approves** the appointment of John Guthrie as a Trustee on the Dunedin (New Zealand) Masters Games Board.

BACKGROUND

- The New Zealand Masters Games is owned by New Zealand Masters Games Limited, and the Dunedin City Council is one of two franchisees.
- 4 New Zealand Masters Games Limited guarantees franchise rights for the biennial New Zealand Masters Games in Dunedin until the completion of the 2036 New Zealand Masters Games.
- The Dunedin City Council has delegated the management and coordination of the biennial Dunedin Masters Games to the Dunedin (New Zealand) Masters Games Trust. The Trust was



formed in 2007 to administer and organise the event. The Trust received notification of Charitable Status in February 2008.

- 6 Trustees are not remunerated for their voluntary role.
- 7 The current members of the Dunedin (New Zealand) Masters Games Trust are;
 - John Bezett Chairman
 - Councillor Damian Newell and Dr Sue Bidrose (DCC representatives on the Trust)
 - Ron Esplin
 - Ron Palenski
 - John Brimble

 - Judy Bevin

DISCUSSION

- The Dunedin (New Zealand) Masters Games Board Trust Deed states that there will be no less than three (3) and no more than ten (10) Trustees.
- 9 The resignation of Ron Mackersy was received in May 2018. Prior to this resignation the Board had been considering the merits of appointing new members to add to its diversity and skill base.
- While under its Trust Deed the Board is not required to appoint new members, with this resignation Trustees took a proactive approach in identifying additional members to enhance diversity of skill base and support wider reach into local sports and community groups. Recommendations were sought from existing board members on the availability of possible members.
- 11 Board Chair Mr John Bezett approached Dr John Guthrie and Julie Ryan to ascertain their interest in being appointed to the Trust. Both have sound business management and marketing experience, governance experience and strong connections with sporting codes and community organisations.
- Dr John Guthrie (most recently as senior lecturer in marketing at the University of Otago) established the University of Otago Business Case Competitions in 2004 and organised regional, national and international business case competitions on a voluntary basis. Within the wider community, Dr Guthrie has been chairman of the Transition to Work Trust since 2007, Eastern Harbour Tennis Club president since 1993, a New Zealand Masters Games executive member (1992-2002) and Scouting New Zealand Otago Area Commissioner (2002-05). - Julie Ryan has recently returned to Dunedin and is a Market Development Manager working for Sato New Zealand Ltd. Ms Ryan has experience working across sectors including procurement, IT and Project Management in both government and private organisations. She has previously held board positions with Otago Netball and New Masters Games. See Attachment B; J Ryan CV.



Both nominees have experience in marketing, bringing a positive contribution to the Board's current direction of sustainability and growing the event.

OPTIONS

Option One – Recommended Option

The Council approves the appointment of Dr John Guthrie and Julie Ryan as Trustees on the Dunedin (New Zealand) Masters Games Board.

Advantages

• The Trust (and Masters Games) benefit from new ideas, skills and the expertise of a wider membership.

Disadvantages

• Risk that the process is perceived as non-inclusive.

Option Two - Status Quo

The Council does not approve the appointment of Dr John Guthrie and Julie Ryan as Trustees on the Dunedin (New Zealand) Masters Games Board and requests the Board to undertake a wider expression of interest process.

Advantages

- May identify other people with additional skill sets who could be appointed to the Board and bring a wider skill base to the Board.
- A more transparent and inclusive process is undertaken.

Disadvantages

- Time delay while a wider expression of interest process is undertaken.
- Risk that the proposed appointees decide not to continue and there is no other interest in the Board roles.

NEXT STEPS

17 That the two proposed Trustees are appointed and take up their roles at the next Masters Games Trust meeting. The Trust continues to plan the organisation of the 2020 Masters Games.
