#### What Dog Registration Fees Support

Your dog registration fees contribute to a range of services that benefit both dog owners and the wider community. These include:

- Maintaining accurate dog records to support public safety and responsible ownership.
- 24/7 Lost and found services to help reunite dogs with their owners, or impound.
- Dog safety education sessions in schools, promoting safe interactions between children and dogs.
- Maintenance of dog exercise areas, ensuring accessible and safe spaces for dogs to be off-leash.
- Neutering programme for community services card holders
- Investigation of complaints, including barking, fouling, roaming, and aggressive behaviour or attacks.
