(‘THE OIL COMPANIES’)  
OF SPECIFIED APPEAL PROVISIONS**

**MAY IT PLEASE THE COURT:**

1. BP Oil New Zealand Limited, Mobil Oil New Zealand Limited and Z Energy Limited (**The Oil Companies**) are an appellants in the following proceedings:
  - i. *BP Oil NZ Ltd and Others v Dunedin City Council ENV-2018-CHC-291*
2. The Oil Companies give notice that they withdraw the following specified points from their appeal, for the reasons set out in paragraph 3 below:
  - a. Appeal point 374 relating to strategic direction Objective 2.7.1 and Policy 2.7.1.2
3. The Oil Companies' concerns relating to these matters have been largely resolved following mediation in relation to the Bulk Fuel Storage provisions, where it was agreed to make no changes to Objective 2.7.1 or Policy 2.7.1.2 in response to the Oil Companies' appeal. The Oil Companies therefore give notice that they withdraw their appeal points relating to Objective 2.7.1 and Policy 2.7.1.2.
4. The Oil Companies are not aware of any party having an issue as to costs associated with its withdrawal of the interests above and does not anticipate any issues given the manner in which this appeal point has been addressed, in a distinct mediation topic to the appeals of any other parties relating to strategic direction Objective 2.7.1 and Policy 2.7.1.2.
