I think that Portobello School to Weirs Road should be improved, as it is narrow and dangerous for bikers, tourists and pedestrians. Did you know that there have been crashes in that particular area due to the unsafe road? My parents will not let me walk there by myself because of the cars that speed through, despite the 40 km limit. They race around tight corners, the police should consider putting in a speed camera! The road should be wider and the walkway should be longer for bikers and pedestrians.

My name is Ivy Larkins, a year 8 student at portobello school. I am writing to you regarding the problematic state of the road from Portobello School to Weirs Road. In December last year I had a car crash with my mother and little sister due to poor road conditions. The other car involved in the crash was a rental car with German tourists.

If you were a tourist and you experienced a car crash along that road, you would probably not want to drive there again. Also if you were renting a car would you want to get it scratched and written off? It would cost you a lot of money. If you were a tourist travelling from far away you might not have

that amount of money, especially if you just paid to go on a big trip. Would you want your kid to get injured in a car crash because of sloppy road conditions? This could all be avoided if you the council put in some speed bumps so that people aren't speeding to reduce speed and increase safety for pedestrians, bikers, and cars.

Lots of people feel that it is not safe to bike or walk along there because there is no footpath. All there is is a tiny piece of offcut along the side of the road. But we all think it would be a much better idea for you to put a couple speed bumps in and a footpath
