**HEARING** at Dunedin on 19 August 2025

## **PROCEDURAL MATTERS**

- [1] The Chief Licensing Inspector commented on the very late submission received from the Applicant on the morning of the hearing. It commented on the Inspector discussing the hearing with media prior to the hearing. Ms Morrison wanted it noted that she has never spoken to media about hearings, not before nor after a hearing.
- [2] The lateness of the submission and the content was not appreciated.
- [3] The matter before the Committee is about the renewal of the underlying on and off-licences held by St Kilda Tavern (2002) Limited, not the holders of the temporary authority, JV Bars Limited.
- [4] The Applicant responded stating the late submission was sent after he read an article in the Otago Daily Times (ODT) which summarised the evidence to be presented to the Committee before the hearing.

[5] After a brief adjournment, the Committee responded that the information in the ODT was from the public agenda which is made available prior to any hearing on the DCC website.

## **HEARING**

- [6] This hearing relates to an application by St Kilda Tavern (2002) Limited for the renewal of both on and off-licences for their premises situated at 2 Prince Albert Road, Dunedin, and known as the "St Kilda Tavern".
- [7] Public notice of the application did not attract any objections. The Medical of Health Delegate did not oppose the application and the Police did not submit a report.
- [8] The Chief Licensing Inspector has opposed the application because the Applicant has not operated the premises for about two years and in that time it has changed operator three times, with each one operating on a temporary authority. The application submitted was not complete due to the Applicant not having operated the premises in that time.

## **Applicant**

- [9] Mr Tolerton is the owner of the premises at 2 Prince Albert Road and obtained their first licence for the premises in 2003. In 2023 the business operating from the premises was sold and the new operator carried on the business as a tavern using a temporary authority.
- [10] Since then, there have been two sales of the business with the third operator relying on a temporary authority while their substantive licence application is determined.
- [11] Mr Tolerton told the Committee he was applying to renew the underlying licence for two reasons. The first is that if he needed to take over the business again he would have a licence in place. The second reason is to allow any prospective purchaser to trade while they apply for and obtain their own licence.
- [12] He said the Inspector made some points when he spoke to her:
  - a. There is no Food Registration applied for this would be done if he was to take back the business.
  - b. Duty managers had not been named on the application he is not running the business so he doesn't have any names but he would look at the staff employed at the time if he was to take it on again.
  - c. The menus submitted have been used in the past. If he took over the business the food offerings would be similar to that shown on the menus.
  - d. The Host Responsibility Policy attached to the application is the one used in the past and meets the requirements.
- [13] Mr Tolerton said he was unaware of any objections to the renewal.
- [14] He said he was aware that the Medical Officer of Health Delegate objected to the Kilda Hospitality Limited licence application because they were an absentee licensee and would not be present often enough to reduce alcohol-related harm, especially as the local community was vulnerable. Many licensed premises in New Zealand have absentee licensees who operate using local management. Mr Tolerton stated that he had been an absentee licensee for the 20 years he operated the premises and had no issues.
- [15] All of the staff employed by the new licence applicant, JV Bars Limited, live locally and some were employed by St Kilda Tavern (2002) Ltd. They are all capable of observing and managing

- any perceived harm that may be arising from the premises. Mr Tolerton noted that there was no evidence of harm being associated with this premises.
- [16] The person managing the premises for the current operator has been there for ten years. She was trained by a previous long-term manager and is very capable of managing the premises for JV Bars Ltd. Mr Tolerton admitted she let herself down recently with regards to the food at the premises but believes this was a result of stress relating to power failures and a freezer full of spoiled food.
- [17] Mr Tolerton would like to see the premises trading as it has since it first opened in 1875 with a licensee that has the approval of the Committee. By renewing his licensees, the process of getting a suitable licensee can continue.
- [18] The Committee asked about the changes in operators and if Mr Tolerton was aware of what is happening. He replied that he was aware of the two sales of the business and that he had approved the changes of leasee to allow the sales to proceed. In response to another question, Mr Tolerton said if JV Bars Ltd are successful in obtaining their own licences, he would be the landlord only and would not have anything to do with the running of the premises.
- [19] When asked about the 'Earthquake Prone Building' notice attached on the Bayview Road side of the premises, Mr Tolerton said they received it a few months ago. NOTE: a check of this notice shows remedial work is to be completed by October 2059.
- [20] The Committee asked what would happen if JV Bars Ltd did not get their licences granted. Mr Tolerton said there were four local licensees who have indicated interest in the premises so he would suggest that JV Bars Ltd speak to these people.
- [21] When asked if JV Bars decided to use the premises for another type of business, Mr Tolerton said the premises would not be compatible with any other type of business.
- [22] The Committee also asked about the condition of the roof/ventilation over the upstairs kitchen area; this was raised at the hearing convened to hear applications by the previous operator. Mr Tolerton said the roof still needed repaired and is booked in to have the work done in the next month or two. Any food that needs prepared is being done downstairs.

#### **Chief Licensing Inspector**

- [23] Ms Morrison is the Chief Licensing Inspector.
- [24] She said she is concerned that the only reason the Applicant is seeking to renew the licences is for commercial gain so that they might secure a long-term tenant for the premises. The current operator of the premises is the third since the Applicant sold the business in July 2023. The business operation outlined in both the renewal applications are vastly different to the current reality at the premises.
- [25] The information in the applications is theoretical only because the Applicant has no control over how the business operates on a day to day basis.
- [26] Ms Morrison detailed the history of the premises' operators since the business was sold in July 2023 and the deficiencies in the renewal applications as stated by Mr Tolerton.
- [27] When she spoke to Mr Tolerton, he said it was in his best interests to have the licences renewed so the current operator could continue to trade until their licence applications were determined.

[28] Ms Morrison was asked what the implications of not renewing the licences would be. She replied that JV Bars Ltd would need to stop operating the premises until such time as their own licence applications were determined. To continue trading they would require the underlying licences to be renewed. Their current temporary authorities expire on 01 September 2025.

#### **Police**

[29] Const. Didham is a member of the Police Alcohol Harm Reduction Unit. She said the Police did not report because of other commitments but supported the position of the Licensing Inspector.

# **Medical Officer of Health Delegate**

- [30] Mr Whipp is the Medical Officer of Health Delegate. He said he is present to support the position of the Inspector.
- [31] He commented that holding an alcohol licence is a privilege, not a right, and questioned if the Applicant hasn't been operating the premises for two years why would they require the licences to be renewed.

#### CLOSING

## **Chief Licensing Inspector**

- [32] Ms Morrison told the Committee that 'technical renewals' were allowed to help other businesses. In this case the Applicant has not been at the premises for the past two years and there is no indication that they intend to operate the business again.
- [33] If the applications from JV Bars Ltd are not granted, the alcohol business is not for the Applicant to sell. It would still belong to JV Bars Ltd, albeit they would not be able to sell or supply alcohol.

#### **Police**

[34] Const. Didham agreed with the Inspector's position. She said the absence of managers and food options on the applications was due the absence of the Applicant from the operation of the premises.

#### **Medical Officer of Health Delegate**

[35] Mr Whipp had nothing further to add.

## **Applicant**

[36] Mr Tolerton had nothing further to add to the prepared statements. He did comment that he would like to see JV Bars Ltd given the opportunity to trade up to the hearing for their own on and off-licence.

# **DECISION**

[37] The matters before the Committee relate to the renewal of the on and off-licences for the St Kilda Tavern so that the current operator can continue to operate while their own applications are processed. In the event their applications are declined, the Applicant in these matters will still have a licence on which any potential new operator could seek a temporary authority.

- [38] The Committee has heard that the Applicant has not had control of the business operating from their premises for the past two years when it was first sold in July 2023. The company who bought the business withdrew their applications when they learned the applications were opposed. They sold the business to another company that had their licence applications declined after a hearing. The business was subsequently sold to a third company and their licence applications are still to be determined.
- [39] The underlying licences held by St Kilda Tavern (2002) Limited are due for renewal. Mr Tolerton seeks to renew the licence so the current occupier can continue to trade while their own applications are determined.
- [40] Opposition was raised by the Chief Licensing Inspector because the Applicant has not had any control of the running of the premises for two years and as a consequence, the applications lacked the required detail needed to make a considered assessment. If the applications made by the current operators were declined, there were insufficient details in the applications to be satisfied the Applicant would operate the premises to the standard required by the legislation.
- [41] In deciding to renew a licence(s), the Committee must have regard to the criteria listed in s.131 of the Act:
  - a. s.105(1)(a) object of the Act; in the matter before the Committee, an assessment of whether the premises is operating according the object of the Act could not be made because the Applicant has not operated the premises for two years.
  - b. s.105(1)(b) suitability of the applicant; the suitability of the Applicant was not raised. In the time he was the absentee licensee for the premises, no issues were identified.
  - c. s.105(1)(c) relevant local alcohol policy; both the premises' licences are within the criteria of the local policy.
  - d. s.105(1)(d) the days on which and hours during which the applicant proposes to sell alcohol; there are no issues in regard to this criterion. The hours proposed by the Applicant are reasonable for the premises.
  - e. s.105(1)(e) design and layout of the premises; issues relating to the roof/ventilation system for the upstairs area were identified at a previous hearing for this premises. Repairs have been scheduled. The design and layout of the premises themselves is not an issue.
  - f. s.105(1)(f) whether the applicant proposes to sell goods other than alcohol, low and non-alcoholic refreshments, and food; this was not raised during the hearing.
  - g. s.105(1)(g) whether the applicant proposes to engage in the provision of other services unrelated to the sale and supply of alcohol, etc.; this was not raised during the hearing.
  - h. s.105(1)(j) whether the applicant has appropriate systems, staff, and training to comply with the law; the Applicant has not operated the premises for two years therefore this could not be assessed. The Applicant indicated that if he was to resume control of the premises, he would ensure appropriate systems, staff, and training would be put in place, as would appropriate food to comply with the legislation. However, at this time, the Applicant does not meet this criterion.
  - s.105(1)(k) any other matter raised by agencies; no other matters were raised.

- j. s.131(1)(b) whether the amenity and good order of the locality will likely be increased by more than a minor extent if the licence was not renewed; amenity and good order was not raised during the hearing.
- k. s.131(1)(d) the manner in which the applicant has sold/supplied, displayed, advertised, or promoted alcohol; this was not raised as an issue because the Applicant has not been operating the premises.
- [42] Having regard to the matters mentioned above, the Committee cannot renew the on and off-licences for the St Kilda Tavern.
- [43] However, we are mindful that there is an operator in the premises who is waiting for the outcome of their own licence applications. The Committee understands the applications will be opposed so a hearing will need to be convened.
- [44] The Committee therefore declines to renew the on and off-licences held by St Kilda Tavern (2002) Limited. Each of the licences will expire on 30 November 2025 which will allow time for the determination of the applications by the current operator.
