### HOST RESPONSIBILITY – GIFTS OF DISTINCTION LTD

This is our written document stating how the management of the premises will provide a safe environment for our customers.

As a remote seller of Gift Boxes, some of which include alcohol, we have put into place on our website the required consent procedure to avoid selling to minors.

This is a two-stage process. When accessing a gift box containing alcohol, a pop up is shown highlighting that the gift box contains alcohol and the lawful requirement age of 18 is required to purchase the gift box containing alcohol. It also asks for confirmation that the recipient is over 18 years of age. The second consent requirement is made at checkout to ensure age-appropriate persons can proceed.

Thirdly, we have a process in place for shipping. Gift Boxes containing alcohol receive a shipping label with **SIGNATURE REQUIRED** - **AGE RESTRICTED** - **NO ATL**. The couriers have an inhouse policy to handle these shipments safely and responsibly.
