2.0 SUBMISSIONS

- 2.1 CHANGE ID A1, A2, A3, B1, B3, B4
- 2.2.1 I support the following Changes advanced via Variation 2 and include:

Change A1 (to amend the family flats provisions);

Change A2 (to permit duplexes and two residential units within one residential building);

Change A3 (to reduce the minimum site size from 500m2 to 400m2)

- B1 (Minimum site size averaging);
- B3 (Density and units on existing sites of any size);
- B4 (Counting of access legs towards site area in GR1)
- 2.2.2 The amendments provide for the intensification of residential land use while maintaining similar residential amenity levels previously controlled through density, now reliant on maintaining existing GR1 bulk and location controls.
- 2.2.3 Additional design controls may be necessary to support existing bulk and location controls in order to maintain streetscape amenity. In some areas where new infill development is located on front sites, there is the potential for new development to contrast so significantly with existing streetscape character that it degrades amenity values, more particularly where multiple house sites are acquired alongside each other (excluding multi-unit developments).

- 2.2.4 That Change ID's outlined above are adopted as notified.
- 2.2.5 Any similar amendments with like effect.
- 2.2.6 Any consequential amendments that stem from the amendments in paragraph 2.2.4 and 2.2.5.
