

No, it was never finalised beyond being a 'draft for consult' report.

3. Is a final version on the DCC web? (I can't find it)

No, as indicated above there is no final version.

4. Was a public consultation done at that time using the OPUS 2017 report?

No public consultation was done at that time using the OPUS 2017 report. Public consultation on the preferred option from the Opus 2017 report took place through the Dunedin City Council 10 year plan 2018-28 and Dunedin City Council 10 year plan 2021-31.

5. If yes, what was the outcome?

Funding for the project was approved in each of these 10-year plans. However, due to concerns over a lack of sufficient natural hazard information and some limitations of the hydraulic model used for options assessment in the Opus 2017 report the project was deferred. Instead, the South Dunedin Future programme was initiated to gather the required natural hazard information and consider adaptation options more broadly. At the same time, improvements have been made to the hydraulic models used for options assessments to address the model limitations and improve confidence in using the hydraulic model for options assessment.

6. If no, why not?

7. Why were the OPUS 2017 report recommendations not acted upon ie: assessed further and a budgeted stormwater upgrade activity put into the next Long Term Plan at that time?

As indicated above, budgeted stormwater upgrade activity was included in both the Dunedin City Council 10 year plan 2018-28 and Dunedin City Council 10 year plan 2021-31. A significant amount of work has been

undertaken to improve confidence in hydraulic models and preferred options are being considered along with the South Dunedin Futures work. Funding has been included in the draft 9 year plan 2025-2034.
