Section 235 of the Sale and Supply of Alcohol Act 2012 states

"A person who is the occupier, or has or takes part in the care, management, or control, of any unlicensed premises commits an offence if that person allows those premises to be kept or used as a place of resort for the consumption of alcohol".

This is a section that the police administer and their legal advice was used to seek that Grandview Gardens apply for an On Licence for that wedding venue. The premises does operate as a BYO venue as this allowed for under section 14 as the holder of an on licence.

The suggestion that the wedding organiser apply for a Special Licence for each event is only applicable if alcohol is to be sold (no sale, no licence required).

The occupier could required that any event be catered for by a licensed caterer. That type of licence allows for the licence holder to provide the food and beverage for an event without the need for a Special Licence.
