Edgar Centre

Submission Goal:

To have future capital investment included in the DCC 9-year plan to replace the Edgar Centre's problematic roof which is causing major disruption to its daily operations.

Background

The Edgar Centre is one of Dunedin's most utilised community assets. The Centre provides enormous benefits to a wide range of citizens; meeting many of the DCC's strategic framework goals.

The Edgar Centre, together with Moana Pool, are two of the region's most vital recreational facilities, both addressing the city's goal of fostering an active community, as outlined in the Parks & Recreation Strategy. Beyond its core sporting function, the Edgar Centre also plays a key role in supporting the Social Wellbeing, Economic Development, and Arts & Culture Strategies through the wide range of large-scale events it hosts.

The Centre now in its 31st year of operation, with 21 indoor courts under the one roof, is the envy of every city and town in New Zealand, for what it is able to provide to its users.

The Centre has over 650,000 visits annually across a wide range of activities, with more than 200,000 participants involved in community sporting programmes alone. The Centre operate 13 hours a day, seven days a week, providing consistent and accessible service to the community.

The Centre is governed by the Dunedin Indoor Sports Venues Trust Board (DISVT), a charitable trust that has developed a strong and effective partnership with the Dunedin City Council (DCC).

The DISVT operates the facility with the support of an annual grant of \$840,000 from the Parks & Recreation Department - a figure that has remained unchanged for over 13 years. An annual rental of \$590,000 is paid to City Property, which owns the building. Over the past decade, the DISVT has reinvested \$3 million of its own funds to maintain and enhance the quality of the Centre.

Upgrades to the Centre paid for by the DISVT include the replacement of artificial turf, installation of energy-efficient LED lighting, new wooden flooring, and improvements to furnishings and equipment throughout the facility. These have ensured the Centre remains a high-quality, well-maintained community asset.

The Issue

The Centre is however now facing a major operational challenge due to a leaking roof - an issue that has progressively worsened over recent years. During sustained periods of rain, leaks disrupt activities across the Centre, particularly above the wooden courts, where play must be halted for safety reasons.

This is no longer a mere inconvenience; it is significantly disrupting local sports competitions, compromising our ability to host regional and national tournaments, and presenting an ongoing health and safety risk. Moreover, the issue is beginning to erode the strong local and national reputation that the Edgar Centre has built over three decades of service to the community.

The Edgar Centre is the 'home base' for four of the five largest participation sports in Dunedin: Dunedin Netball, Basketball Otago, Futsal South, and Volleyball Otago. We also host other key sports organisations, including Tennis Otago and Otago Table Tennis. Collectively, these sports deliver 28 weekly competitions throughout the year. In addition, the Centre is a vital training hub for over 10 other sports codes across the city, including Otago Cricket's high-performance centre.

Unfortunately, all of these sporting bodies have experienced disruptions due to the ongoing roof leaks, which have rendered multiple courts unusable during wet conditions. Each of these organisations has expressed unanimous support for our submission seeking urgent investment in the roof. Letters of endorsement, along with details of the effects on their competitions, are included in the appendix. For example, last winter, Dunedin Netball had 87 competition games affected due to court closures caused by roof leaks.

In 2024, the Centre hosted 28 regional tournaments and 7 national or South Island tournaments, delivering substantial economic and promotional benefits to the city. A key example of this was the hosting of the New Zealand U18 National Netball Tournament held over five days in July, which brought 45 teams and approximately 900 visitors to Dunedin. Events of this scale provide a vital boost to local businesses and showcase the city as a premier sporting destination.

The ongoing roof issues are now jeopardising the Centres ability to continue attracting and retaining such events. During the U18 tournament, rainfall caused noticeable disruption - an issue formally acknowledged by Netball NZ. The Centre is currently unable to guarantee that the venue will meet the standards expected for national-level indoor competitions. Without urgent attention to this matter, the Centre risks losing high-profile tournaments and the associated economic and reputational benefits they bring to Dunedin.

Capital Investment:

City Property have been trying to find a suitable long-term solution to the roofing issue for the last 5 years, unfortunately without success.

A considerable amount has been spent, and further allocations have been budgeted for in the coming years.

City Property however acknowledges that the only viable long-term solution is a redesigned roof - one that is compatible with the Centre's location on reclaimed land and the specific weather conditions we face.

Importantly, the building's structure remains sound and does not require further structural investment. Although the DISVT Board is concerned that long term leaking can undermine structural timber in the roof. Relocating the Centre or developing a new facility elsewhere would be both unrealistic and financially prohibitive. For comparison, Christchurch's new Parakiore indoor recreation complex (not the new stadium) has cost \$365 million.

In contrast, City Property has estimated that a flexible roof structure and ventilation system suitable for the Edgar Centre would cost approximately \$15 million [as referenced in the ODT article dated 21 June 2024 and the City Councillors' briefing during their visit to the Centre on 10 September 2024].

Current 9-Year Plan

The Edgar Centre does not feature in the existing 9-year strategic plan for additional expenditure outside of the Centres current operational spend. In the Trusts view funds must be set aside for the future proofing of one of the City's most utilised public assets.

In the existing 9-year plan \$1.89 billion has been set aside for major capital expenditure. In the recreation sector Moana Pool has the biggest allotment for upgrades with \$18.5 million. \$17.78m has been included for investment into playgrounds.

\$18 million of increased funding has been set aside for attracting events to the Forsyth Barr Stadium and the Town Hall – this has been set at \$2 million per annum. The Centre can attract large national tournaments with regularity, as outlined earlier, if the Centre is maintained to the expected levels.

Survey

Over 3 weeks we conducted an online survey of our users to seek support for this submission. We received over 1000 responses.

- 87% of respondents had experienced disruption to their sport due to a leak in the roof.
- 98% of respondents supported "investing in a modern roofing system's" inclusion in the 9-year plan this was with the understanding that the expected cost could be \$15m and funded via rates.
- 25% of respondents added additional comments to their survey.

Several examples of the responses follow -

- ➤ The Edgar Centre is a great City resource that is utilised by 1000's and provides residents / ratepayers a place to enjoy indoor sporting activities, contributing to our collective health in many ways. As a high user of the centre, we have had several and consistent disruptions over the years to our sporting activities due to the leaking roof. We appreciate the Edgar Centre team for the huge efforts in trying to band-aid the problem due to an overdue upgrade. Please prioritise this investment.
- This is a major community venue that arguably has more connectivity than the stadium it gets more use by the community and athletes and provides more synergies with the future investment into young people. it must stay and the facility must be preserved and maintained for everyone to enjoy
- Any short-term cost will benefit many in the long term
- ➢ I've seen first-hand how vital this facility is, not just for athletes, but for the wider community. It's a central hub for sport and recreation in Dunedin, and protecting its future is essential. Maintaining the Edgar Centre at a high standard is critical for: Protecting our main community asset that supports physical activity, health, and wellbeing for people of all ages and backgrounds. Ensuring Dunedin continues to attract regional and national sporting events, which boost the local economy and pride in our city. Maximising value from existing infrastructure, rather than letting it deteriorate and ultimately needing costly replacement. Safeguarding a facility used by hundreds of thousands each year, ensuring it remains safe and available for current and future generations. This is not just an investment in a roof; it is an investment in our community, our young athletes, and our ability to host events.

- The Edgar Centre is an integral part of Dunedin's school sporting activity. You only have to be there on a Monday/Tuesday/Wednesday/Thursday/Friday 3pm 7pm and beyond, with the carpark gridlocked and 1000's of children and adults alike, to see the epic value of this place. It deserves love and attention as the years go by to keep it as one of the most well used venues in Dunedin and Otago.
- The Edgar is such an important resource and maintaining it is vital for ongoing use. We want our community to be active and engaged and connected and if we don't look after it that connection will begin to break. Cancelled netball games due to leaks were very disappointing and I am sure our kids weren't the only ones affected.
- > The Edgar Centre is the epicentre of children's (and adult) sport in Dunedin. Funding a new roof for this facility should be a priority.
- > The leakage problem should have been addressed years ago and it keeps getting patched rather than fixed properly. If you are going to fix it, do it right.

Solution

In light of the substantial community, economic, and reputational value the Edgar Centre delivers to Dunedin, we respectfully request that the Dunedin City Council prioritise funding for the roof replacement project in the 9-Year Plan.

A commitment to this investment - estimated at approximately \$15 million - would safeguard the long-term viability of a facility that supports thousands of users each week, underpins the city's major participation sports, and generates year-round economic activity through regional and national events.

We are confident that, with council support, we can ensure the Edgar Centre continues to be a cornerstone of community sport and a premier event venue for Dunedin for decades to come.

The Edgar Centre does not expect ratepayers to wear the full cost, with a full understanding that rate increases, and debt levels of the city can only stretch so far. If this first step is achieved, we would also look to contribute financially by using our charitable status to attract significant grants from funding trusts, along with a levying a percentage increase on all users.

Sport Otago would like to provide this letter of support to the Edgar Centre as part of their submission to the Dunedin City Council's (DCC) 9-year plan. Sport Otago is fully supportive of the Edgar Centre's application to Council for a new roof.

The Edgar Centre is an important and critical asset for the Dunedin community and replacing the roof would future-proof the venue for years to come. The Edgar Centre is a critical cog in the recreational facilities across Dunedin and is a multi-use indoor venue that is relied on heavily for indoor sports across the community. It caters for high volume sports such as basketball, volleyball, futsal and netball, through to tennis, rugby, pickleball and a host of other sporting and recreational activities. The Edgar Centre is also major contributor to the wellbeing strategy of the city and is a critical component in getting Dunedin people active.

The Edgar Centre was identified in the Coastal Otago Spaces and Places Strategy 2023 as an important indoor venue that was extremely well used, with some sports having to cap their competitions. The strategy also identified the Edgar Centre as a high risk venue due to the limited alternative venues to support the numbers of activities/competitions being run from the Edgar Centre. Keeping the building maintained and up to an adequate standard was one of the key mitigation factors identified to minimise the risk of the Edgar Centre being out of action.

Sport Otago fully supports the Edgar Centres submission to the DCC's 9-year plan as this is a strategically important community facility that plays a vital component in keeping our community active.

RE: EDGAR CENTRE SUBMISSION TO THE DUNEDIN CITY COUNCIL 9 YEAR PLAN

The board of Dunedin Netball support the Edgar Centre submission to the DCC to include provision in the 9 year plan to re-roof the main hall of the Edgar Centre.

Netball was a founding member and has been a constant user of the Edgar Centre since 1994. These are the only court facilities available to utilise in Dunedin with no other venues either indoors or outdoors available to accommodate over 3500 players, coaches and officials every season.

Problems with the Edgar Centre leaking roof and condensation issues have been well publicised over the years with articles in the Otago Daily Times since 2010. Meetings with various Dunedin City Council staff have been attended over the years with maintenance plans proposed and some remedial work completed on the roof over the last couple of years. The work that has been done however, has not prevented roof leaks in any kind of rain event, including persistent drizzle and heavy downpours, making any number of courts unavailable. When leaking appears on courts, either wood or turf, it creates a dangerous health and safety slipping hazard.

In 2024, Dunedin Netball held six season competitions across four days of the week with a total of 293 teams. We hosted eight tournaments and festival days including the Netball New Zealand U18 National Championships with a total of 209 teams, the majority of those teams from outside of the Dunedin area. During the local competition season, due to unsafe court conditions caused by the leaking roof, we were forced to cancel 34 games, and 54 games had to be moved or delayed. A further 23 games were moved during tournaments held inside the Edgar Centre.

The Edgar Centre is a critical and integral part of the Dunedin City Council's community facilities. Hundreds of thousands of people pass through the Edgar Centre doors every year and Dunedin City Council has a responsibility to ensure the

accessibility and safety of the venue for all users. The Dunedin City Council's Parks and Recreation Strategy 2017-2027, Sport and Recreation Action Plan as published on the council website has an objective: 2 Open spaces and facilities support Dunedin's communities to thrive and a priority to provide appropriate, quality, fit-for-purpose open space, sport and recreation facilities at regional, sub-regional and local levels and also maintain and invest in major event infrastructure to attract sporting events that bring domestic and international participants and visitors to Dunedin.

The continued issues with the Edgar Centre main hall roof are preventing our community from participating in physical activity. The facility is not fit for purpose, an indoor venue should be able to be utilised in all weather and not be affected by cancellations due to unsafe conditions caused by rain. Our sporting organisations are overlooking Dunedin as an appropriate national event indoor venue due to the issues encountered with leaking courts, limiting the ability to attract sporting events that bring domestic and international participants and visitors to Dunedin.

Dunedin City Council staff publicly stated to Edgar Centre and Dunedin Netball in a reply to questions from the Otago Daily Times on 20 June 2024 that, "Ultimately, the Edgar Centre needs a new roof and venue-wide mechanical ventilation system to resolve weather-related issues at the venue. This would come at significant cost, estimated to be more than \$15 million, and we need more information about investment in multi-sports facilities first." If this is the solution, the expense must be included in the Dunedin City Council 9 Year Plan 2025-2034 to ensure one of the most used community sport, recreation and event facilities in the city can continue to provide a safe and dry indoor space that is accessible to all.

The current draft Dunedin City Council 9 year plan indicates investment in other community recreation facilities like Moana Pool and Forsyth Barr Stadium. The Edgar Centre sport, recreation and event community including Dunedin Netball implore Dunedin City Council to consider including provision for the replacement of the Edgar Centre main hall roof in the 9 year plan.

To Whom It May Concern,

My name is Andrea Ryder, and I serve as the Game Development Officer for Tennis Otago.

At Tennis Otago, we utilize the Edgar Centre throughout the year, particularly on weekends, for a variety of events including junior and senior interclub matches, adult and senior tournaments, and, seasonally, our business house leagues. The Centre is invaluable to us, not only during inclement weather but also when our local clubs are unable to accommodate the demand for additional court space.

I am also aware that some of our affiliated clubs reserve courts at the Edgar Centre for similar purposes, such as during adverse weather conditions or for events like LOVE TENNIS in September.

Having access to the Edgar Centre has been instrumental in enabling us to host larger events, drawing participants from outside the Dunedin area, particularly for tournaments and interclub competitions. While the Steveson Tennis Centre provides an additional facility with multiple courts, it is the Edgar Centre that often allows us to continue operations during rainy conditions, as tennis is primarily an outdoor sport.

I am writing to express our support for the installation of a new roof at The Dunedin Edgar Centre / More FM Arena.

As a vital community asset, this stadium serves as a pivotal gathering place for local events, Te Mana Āhua Ake hosts the annual Otago Polyfest. We have hosted our event in the stadium for over 10 years. Progressively our numbers have increased to 10,000 people over 5 days. Our use of the venue has extended to use a large portion of the venue. It is currently the only venue in Dunedin that can host an event as big as ours for consecutive days.

Our participants range from pre-school age through to elderly members of the audience. Health and safety considerations are paramount, the logistics of running a rotation of buses all day, mobility access and a constant procession of audience.

However, the current condition of the roof has become an ongoing hazard. Last year, safety covers had to be placed over water-damaged areas, highlighting the urgent need for repairs. This was a constant risk mitigation between our production team and the venue team.

Without proper action, these issues will only worsen, putting both students and attendees at risk. A new roof would not only address these safety concerns but also enhance the stadium's functionality. With the ability to provide blackout conditions, performances would benefit from improved lighting control, creating a more professional and immersive experience for students and audiences alike.

Investing in this improvement would strengthen our community by ensuring a safe and high-quality venue for school events, cultural performances, and other gatherings. I encourage any upgrade of the roof for the benefit of the wider community.





Q1 What sports or activities do you play or spectate at the Edgar Centre(tick all boxes that apply):




