

Dear Tessa,

We have been thinking long and hard about how to find a solution that will work for all parties. We have moved the location further back from the road and side boundaries and ensured that it would comply with the DCC Rural Residential side yardage requirements as you suggested. To reduce the visual impact even more we have dropped the roof angle to minimise the overall height of the house.

The orientation of the house follows the slope as we will be "cutting in" to lower the house with respect to the land profile. Moving further back would require us to orient unfavourably with regards to building a sustainable passive solar home.


Included is an aerial photo from DCC with an overlay of the new proposed house location and a profile with my estimate of the viewing angle you would have from the location marked with a star on the aerial photo. Moving toward your house from the marked location would result in the our home being completely blocked from view by the shrubs on your property. As we agreed we will plant shrubs along our side of the boundary that will grow to between 2 and 3 meters tall creating a natural barrier without impinging on your view of Mt Cargill.

Dear Tim & Anna.

Thank you for your e-mail of 1/09/2015 regarding the resource consent process for 22 Cleghorn St. While I appreciate you keeping me informed, I am greatly saddened that you do not feel able to compromise at all on the proposed building site of your planned home.

I do not enjoy finding myself in this situation - indeed quite the opposite, I am finding it very distressing - but I must again reiterate my opposition to your plans. You have said how much you want to live in this neighbourhood and be part of this community and yet you seem completely unaware of (or indifferent to) the impact your plans will have on those around you. Those of us who live here all share very similar values; we have chosen to live here so that we can have the space, privacy and quiet that are lacking in the city and suburbs; we are good neighbours in no small part because the configuration of this small community allows us to maintain our privacy and therefore our social equilibrium. This has always been a very special neighbourhood to live in because the people who come here have been sensitive to and respectful of the needs of their neighbours.

By insisting on building on the crown of the hill, you will crowd and close in the open rural aspect that is a distinctive part of the character of Cleghorn St. By insisting on your right to build as close as you legally can to our shared boundary, you will compromise the peace and privacy that is what I most cherish about my home. Your plan indicates an intention to plant on your boundaries to screen the visual impact of your house but the reality is it will take several years before any planting is sufficiently established to mitigate the impact of what you propose to do; if indeed plantings can be established given the adverse weather conditions on the site. Your aspiration to plant an orchard and to have a large vegetable garden on the southwest facing slope suggests you have a totally unrealistic expectation of what you will be able to achieve up here. It has taken me fifteen years to establish a garden and I have only been able to achieve that by compromising and growing the most hardy of plants and even then there are areas on my property where fierce winds and thin soil have defeated all attempts to establish shelter.

As you said when you visited me, you may indeed get what you want through the consent process, but only by taking what I already have. It would seem that my loss and the distress you are causing me is collateral damage you are willing to sustain.

Hello Tessa.

As you may have realised our consent application is moving slower than we had imagined. This has given us ample time to ponder our plans since we last had contact. Although we are very happy and enthusiastic about our project we do not savour the idea of upsetting you, one of our future neighbours, before we even start building.

You have mentioned before that you would much perfer us to move the building site further down and further back on the slope. With moving further toward the back of the section we are very concerned the house may become visable above the ridge line when coming up the North road. We could possibly move down another few metres and reorient the house slightly to in effect move back on the property a couple of meters. This would make the distance to your boundary approximately 12-14 metres. Could this be enough to alleviate your concerns?

If not, would you be able to indicate an area on the section that you would feel comfortable with? I can come by any time this week with a map or aerial photo if you are willing to discuss this further.
