- 1 The Otago Regional Council wishes to be a party to the following proceedings:
 - 1.1 The appeal dated 19 December 2018 by Stephen Gregory Johnston from the Dunedin City Council's ("DCC") decisions on its Proposed Dunedin City District Plan ("2GP").
- 2 The Otago Regional Council is:
 - 2.1 A local authority;
 - 2.2 A person who made a submission on the subject matter of the appeal, including Coastal Values, Natural Hazards and Urban/Rural Design and Growth.
- The Otago Regional Council is not a trade competitor for the purposes of section 308C of the Resource Management Act 1991 ("the Act").

 - 6.4 The relief will derogate from a strategic and coordinated approach to urban growth and development;

- 6.5 The relief will derogate from well-designed urban growth and development;
- 6.6 The relief does not promote sustainable management and is therefore contrary to Part 2 of the Act;
- 6.7 The relief does not give effect to and is not needed to give effect to the National Policy Statement on Urban Development Capacity;
- 6.8 The relief does not give effect to the partially operative Regional Policy Statements 1998 and 2019, and is inconsistent with the proposed Otago Regional Policy Statement;
- 6.9 The relief sought is contrary to the New Zealand Coastal Policy Statement.
- 7 The Otago Regional Council agrees to participate in mediation or any other alternative dispute resolution of the proceedings.
