We have lived at 149 Dukes Road for 6 and a half years. To our knowledge the house has not been flooded before and certainly not after we moved here, even during the 2017 flood.

The application of Hazard 1A flood overlay zone is unfare as we would not be able to make any appropriate improvements to prevent any flooding if it were to occur in the future as any building concents would be probibited. This does not make sense to me as surely any flood preventative measures taken at the land owners expense, has to be beneficial to everyone.

If the Silverstream was to run at capacity as it was origionally designed to do (175 cumecs instead of the 115cumecs it is at the moment), the impact of the flooding would be greatly reduced. This has to be put down to lack of maintainence over the last 50 years.

We all choose to live here because we love the area and take pride in our properties and for it all to be devalued at the stroke of a pen because the alternative is too hard, is grossly unfare. That is why we all pay our rates, to have the environment in which we choose to live maintained and to keep us safe.
