Summary of Decisions Requested for Variation 1: Minor Amendments to the Proposed Second Generation Dunedin City District Plan

Pursuant to Clause 7 of Schedule 1 of the Resource Management Act 1991 (RMA), the Dunedin City Council (DCC) gives notice that the Summary of Decisions Requested to Variation 1: Minor Amendments to the proposed Second Generation Dunedin City District Plan (2GP) has been prepared and is available, alongside copies of all submissions, for inspection at:

- https://www.dunedin.govt.nz/2GP-variation-1-minor-amendments
- public libraries and/or service centres at Dunedin, Middlemarch, Mosgiel, Port Chalmers, Blueskin Bay (Waitati) and Waikouaiti.

The Summary of Decisions Requested report is a concise summary of the decisions requested in the submissions on Variation 1 to the 2GP which closed on 18 December 2019. It is not the full or exact content of submissions. It is prepared to enable the further submission process which is set out in Clause 8 of Schedule 1 of the RMA.

What can a further submission cover?

A further submission can only be made in support or opposition to a point raised in another person's submission.

Who can make a further submission?

The RMA limits who can make further submissions to:

- any person representing a relevant aspect of the public interest
- any person that has an interest in Variation 1 greater than the interest that the general public has
- the local authority (Dunedin City Council).

It provides an opportunity for people who may be affected by an original submission to have their views considered. You do not have to have made an original submission to participate. If you have made an original submission you do not need to repeat submission points made in that submission as they will already be considered.

Further submissions open on 29 January and close at 5pm Thursday, 13 February 2020.

How do I make a further submission?

The RMA requires further submissions to be in a prescribed form (Form 6 Schedule 1). An
