Hi Chris

The DCC are starting to get close to being able to lodge another notice of requirement for designation for the section of arterial whose designation was quashed by the High Court. I am trying to figure out what conditions are appropriate for the new designation. The old one state an Archaeological Authority should be gained from the HPT.

As part of this NOR there will be new mitigation works that involve the construction of a new access road into 80 Anzac Ave from SH88. This new access road will be about 100m long 7 m wide and involve 700 m3 of earthworks. The road will be to SCC local road standard. See attached plans.

I spoke to Matt Schmidt of HPT and he said as the legal description for the area of land is within the original authority (although not covered by the description of works) for the construction of SH 88 he would be loathe to issue a new authority and would consider an Accidental Discovery Protocol. However Matt said he would rely on your recommendation on whether you thought an ADP and/or monitoring during earthworks was appropriate for this area (something about an old wharf pile being found in the area).

Can you have a look at the plans and let me know what your recommendation would be ?

I have attached the plans, authority , old legal descriptions and new description and designation plan for the area in question.
