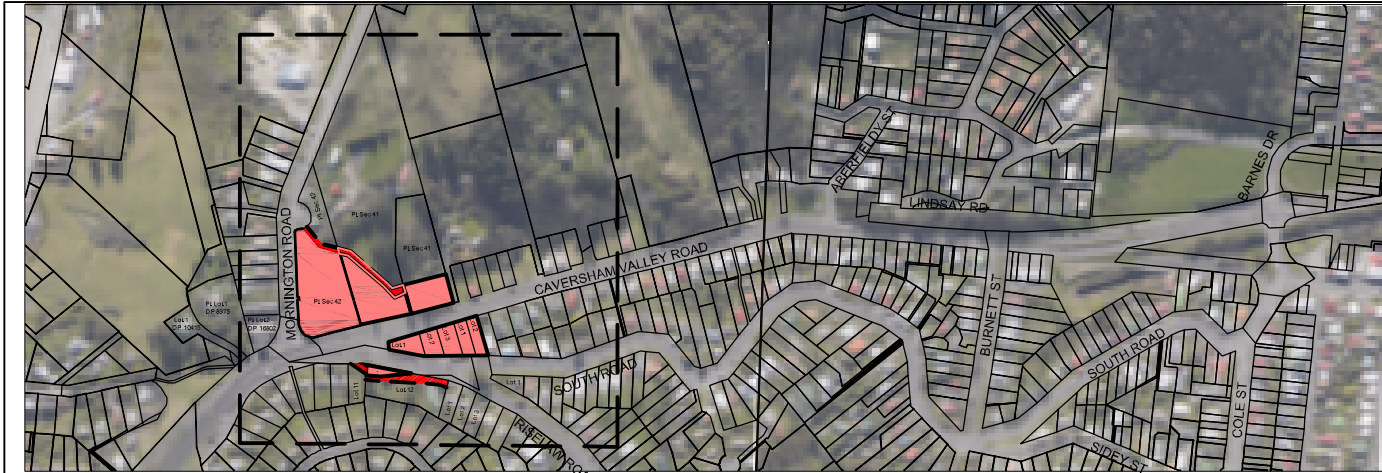




LOCALITY PLAN

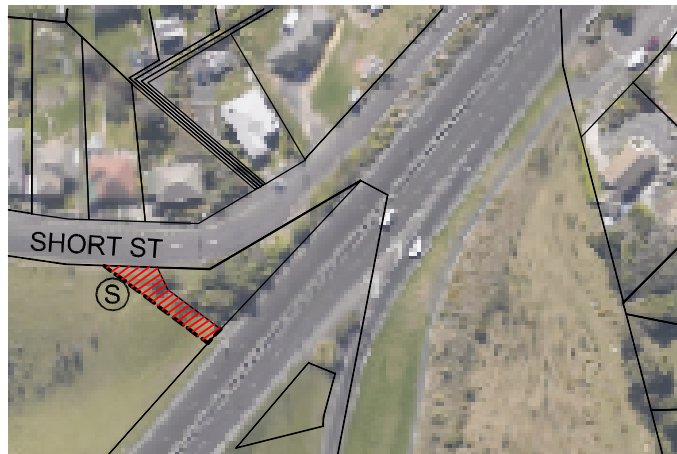
