PROPOSED DISTRICT PLAN CHANGE 10 – Transportation Rules and Definitions

DUNEDIN CITY DISTRICT PLAN

Clause 5 of First Schedule, Resource Management Act 1991

Council-initiated plan change

Dunedin City Council gives notice that it has prepared the following Proposed Plan Change to the Dunedin City District Plan:

Proposed District Plan Change 10 makes a number of improvements to the rules and assessment matters of District Plan Section 20: Transportation, and reviews associated definitions in District Plan Section 3: Definitions. These improvements resolve concerns raised during a recent evaluation of Section 20, and include: provision for bus shelters within the road reserve and in other road corridors; clarification of the wording of certain rules and definitions; and updating of certain design standards and terminology. The proposed plan change also makes a number of minor amendments of a consequential nature to transportation-related rules and assessment matters in other parts of the District Plan.

The proposed plan change neither alters nor calls for submissions on any of the existing resource management issues, objectives, policies or methods in the District Plan.

The key parts of the proposed plan change include:

- Amendments to transportation-related definitions in Section 3: Definitions of Volume 1 of the District Plan.
- Amendments to rules and assessment matters in Section 20: Transportation of Volume 1 of the District Plan.
- Minor amendments of a consequential nature to transportation-related rules and assessment matters in Sections 8: Residential, 9: Activity, 10: Industry, 11: Port, 18: Subdivision Activity and 25: Airport of Volume 1 of the District Plan.
- Amendments to the legend for zone maps in Volume 2 of the District Plan.

The submission must be in Form 5 of the Resource Management (Forms, Fees and Procedures) Regulations 2003 or similar, and must state whether or not you wish to be heard on your submission. Copies of this form are available from the locations

Submissions close at **5pm on Monday 1 February 2009**.

The process for public participation in the consideration of the proposal under the Act is as follows:

- After the closing date for submission, the Council will prepare a summary of the submissions and publicly notify the availability of that summary.
- There will be an opportunity for:
 - i. any person representing a relevant aspect of the public interest;
 - ii. any person that has an interest in the proposed plan change that is greater than that of the general public; and
 - iii. the Dunedin City Councilto make a further submission either supporting or opposing a submission or submissions already made.
- If any person making a submission asks to be heard in support of his or her submission, a hearing must be held.
- The Council will give its decision on the proposed plan change (including its reasons for accepting or rejecting submissions).
- Any person who has made a submission has the right to appeal the decision on the proposed plan change to the Environment Court.
