Clause 7 of First Schedule, Resource Management Act 1991

Under clause 8 of the First Schedule of the Resource Management Act 1991, this stage provides an opportunity for the following parties to make a further submission either supporting or opposing a submission or submissions already made:

- any person representing a relevant aspect of the public interest;
- any person who has an interest in the proposed plan change that is greater than that of the general public; and
- · the Dunedin City Council itself.

The further submission must be in Form 6 of the Resource Management (Forms, Fees and Procedure) Regulations 2003 or similar, and must state whether or not you wish to be heard on your submission. Copies of this form are available from the above locations, can be downloaded from www.dunedin.govt.nz or will be mailed to you if you phone 477 4000, or email planning@dcc.govt.nz.

## Submissions close at 5pm on Friday 31<sup>st</sup> August 2012.

The process for public participation in the consideration of the proposed plan change under the Act is as follows:

- if someone making a submission asks to be heard in support of that submission, a hearing must be held; and
- the Council will give its decision on the proposed plan change (including its reasons for accepting or rejecting submissions); and
- anyone who has made a submission has the right to appeal the decision on the proposed plan change to the Environment Court.

Please note that within five working days of making your further submission to Council, you must provide a copy of your submission to any original submitter(s) that you have opposed or supported.
