GUIDE TO THE SUMMARY

The first stage of the process for Plan Change 8 provided an opportunity for anyone to make a submission. The period for making submissions closed on 25 July 2008. A summary of decisions requested by persons making submissions is contained in this document.

This is the second stage of the process for Plan Change 8 providing an opportunity for anyone to make a further submission. A further submission is a submission in support of, or opposition to, an original submission made. This stage is not another opportunity to make new submissions on the Plan Change itself, as a further submission can only relate to a submission that has already been made.

How the summary is organised

Submissions on Plan Change 8 have been summarised and arranged in three ways to facilitate further submissions. The submissions have been arranged by:
