

25.2 Archaeological Sites Registered by the New Zealand Historic Places Trust

The archaeological sites included in this schedule are sites registered by the New Zealand Historic Places Trust. This schedule does not contain all sites, as there are many more which are recorded in the New Zealand Archaeological Association database (CINZAS) and there will be many other sites which have not been recorded. The New Zealand Archaeological Association database (CINZAS) is held by regional filekeepers who may be contacted via the Department of Conservation or the New Zealand Historic Places Trust.

An archaeological site is one associated with pre-1900 human activity or a pre-1900 shipwreck, that may provide evidence relating to the history of New Zealand. Under the Historic Places Act 1993, all archaeological sites (both recorded and unrecorded) require the authority of the New Zealand Historic Places Trust before any work can be undertaken which would destroy, damage or modify the site.

Any person and/or group carrying out activities on the archaeological features listed in this schedule and/or carrying out an activity/activities on the site of which an archaeological feature is listed, must consult with the New Zealand Historic Places Trust.

Note: The Eastings and Northings locate the site to within 100 m.
