

GRANTS REVIEW UPDATE

Department: Civic

EXECUTIVE SUMMARY

- A review of grants is currently being undertaken by the Grants Review Group (the Review Group) as part of the 9 year plan. The purpose of this report is to provide an update of the work being undertaken by the Review Group.
- 2 The report discusses the following:
 - Setting a strategic direction for future grants, including identifying the outcomes that Council wants to achieve through the provision of grants funding,
 - Annual Plan and Long Term Plan funding requests
 - Grants subcommittee and Dunedin Heritage Fund considerations, and
 - 9 year plan grant funding considerations.
- As the work of the Review Group is still in progress, the report makes recommendations on the process for including grants funding in the 9 year plan, including "ring fencing" the quantum of grants funding to that provided for in the 2024/25 Annual Plan.

RECOMMENDATIONS

That the Council:

- a) Agrees that the draft budgets for grants, excluding the grant to Tūhura Otago Museum, is ringfenced, to the amount of grants funding that was provided for in the 2024/25 Annual Plan.
- b) Agrees that the unallocated funding of \$272,000 be available for funding requests that may come through the submission process on the 9 year plan 2025-34.

BACKGROUND

- In 2023, a request was made by Council to undertake a review of grants, to support the preparation of the 10 year plan 2024-34. A Grants Workstream was established to undertake the review.
- In September 2023, a report was presented to Council that provided an overview of the DCC grant categories, budgets, and expenditure. The report identified the need for more work to be

- undertaken to look at and understand grants from across all of Council. It also noted that the DCC's Grants Management Policy was due to be reviewed in 2024.
- At its meeting on 27 February 2024, Council decided to proceed with an Annual Plan 2024/25, followed by a 9 year plan 2025-34 (9 year plan).
- A report was presented to the 12 March 2024 Council meeting, providing an update of the work completed by the Grants Workstream. The report noted that the next steps included the need to define the grant review process to complete the review.
- At its meeting on 31 July 2024, Council approved a Terms of Reference for the continuation of the grants review that had commenced in 2023. Council resolved:

Moved (Mayor Jules Radich/Cr Bill Acklin):

That the Council:

- a) **Approves** the draft Terms of Reference for the Grants Review.
- b) **Notes** that updates on the review would be as required and to either the Community Services Committee or Council.

Motion carried (CNL/2024/001)

9 The Terms of Reference established the Review Group, its membership being the six Councillors on the Grants subcommittee and support staff. The Terms of Reference is at Attachment A.

DISCUSSION

Summary of DCC Grants

10 DCC grants budgeted in the 2024/25 year totalled \$13.7 million. Of this, \$6.6 million is covered in the grants review in accordance with the approved Terms of Reference. A copy of the Terms of Reference is at Attachment A.

11 Table 1 below shows a summary of the 2024/25 DCC grants allocation.

Further work is being undertaken to ensure all grants have been captured, and correctly categorised as grants. For example, the Mayor's and the Chief Executive's discretionary funds have been removed from the grants list, as they are not grants. These funds total \$50k. The split of these funds has changed in the 9 year plan budget, with the Mayor's fund now \$40k (previously \$30k), and the Chief Executive's fund now \$10k (previously \$20k).

Setting a strategic direction for DCC grants

- 12 The Terms of Reference approved for the review provides that the purpose of the review is:
 - "to review the current grant pools provided by the DCC and recommend changes to ensure the grants framework aligns with Council's outcomes".
- 13 The Grants Review Group is currently considering what outcomes Council wants to achieve through the provision of grant funding.
- 14 Council is currently working through a process to review the Strategic Framework, alongside the Government rewriting the purpose of Local Government in Section 10 of the Local Government Act.
- 15 It is important that Council aligns the grants framework with both the revised purpose of Local Government, and the agreed changes to the Strategic Framework. These will inform what the

outcomes and priorities are that will contribute to achieving Council's agreed strategic goals. Once changes are confirmed, progress can be made on developing the grants framework.

Annual Plan and Long Term Plan funding requests

- Requests for funding are typically received through the annual plan and long term plan submission processes, with decisions on these requests made at the deliberations meetings.
- 17 The Review Group recommends that this process should change. Funding requests should instead go through the grant application and decisions processes, to ensure fairness, equity, and alignment with Council's desired outcomes.
- Removing funding requests from the submission processes to the grants process will not be possible for this 9 year plan and the next Annual Plan process, but it is recommended that this proposal be included in the 9 year plan consultation document and other engagement material over the next year, to ensure awareness of this new process, in time for the next 10 year plan 2027-37.

Grants Subcommittee

- 19 The Grants Subcommittee makes decisions on most of the contestable grants, Waste Minimisation Grants and grants funded by Creative NZ. Decisions made by the Grants Subcommittee account for approximately \$2.25 million of the total grants budget.
- The Committee Structure and Delegations Manual provides that the Grants Subcommittee membership consists of six Councillors and nine external members, representing the community, mana whenua, the events sector, the arts sector, the Department of Conservation and Creative NZ. The different contestable grants require different mixes of external representatives.
- 21 The Review Group is considering what the best mechanism is for making decisions on contestable grants, for example, does the Grants Subcommittee remain or could a committee of Council make the decisions; if the Grants Subcommittee was to remain, what is an appropriate membership structure.
- A report will be presented to Council at a future date with recommendations for decision making on contestable grants.

Dunedin Heritage Fund

- Decisions on applications to the Dunedin Heritage Fund are made by the Dunedin Heritage Fund subcommittee, in accordance with the provisions of the Trust Deed for the Dunedin Heritage Fund. The Committee Structure and Delegations Manual provides that the membership of the subcommittee consists of two councillors, three representatives appointed by Heritage NZ and two staff members.
- The Dunedin Heritage Fund received \$680,000 for grants funding in 2024/25. Council may wish to consider reviewing the use of this funding, and if some of it may be allocated towards heritage work undertaken by DCC staff.

9 year plan grant funding considerations

- It is recommended that the total grant funding, excluding the grant paid to Tūhura Otago Museum, as provided for in the 2024/25 budget, and as shown in table 1, be ring-fenced in the 9 year plan budgets. Draft budgets have been prepared on this basis.
- A detailed list of allocation of the grants budget is shown at Attachment 2. This list shows how these funds were allocated in 2024/25, and how they have been allocated in the draft 2025/26 budget. It details those grants no longer required, and those that will have their funding allocation expire on 30 June 2025. The expiring grants relate primarily to those community service agreements and service level agreements that were rolled over for one year, following the decision to have an Annual Plan, followed by a 9 year plan.
- 27 It is recommended that the unallocated budget of \$272,079 as shown in Attachment B, i.e., the funding that expires on 30 June 2025 and the budget no longer required, be available for funding requests that may come through the submissions process on the 9 year plan.
- A budget amount of \$2.28 million has been included in the Grant budget for 2025/26. The purpose of this grant is discussed in the Vibrant Economic Draft Operating Budget 2025-34 report on the agenda.
- For the next and subsequent 10 year plans, it is recommended that a process for community service agreements, service level agreements, property arrangements and other funding requests will be undertaken, in time for Council to approve the application of funds through each 10 year plan budget process. These agreements would commit funding for up to a three year period, with updates made through subsequent Annual Plan budget processes.

30 As this is an update report, there are no options.
