The Dunedin City Council is required to appoint one person to the Board of Dunedin Indoor Sports Venue Trust.

#### RECOMMENDATIONS

### **BACKGROUND**

The Council has the ability to appoint a Trustee to the Dunedin Indoor Sports Venue Trust Board. Mrs Ruth Stokes, previous General Manager Infrastructure and Networks was one of the three Dunedin City Council appointees until November 2017. This is a current vacancy that requires appointment.

#### DISCUSSION

- The Edgar Centre is a significant community sports and events facility and service provider in the City, and it is important that the Council has active representatives on the Board to ensure oversight and governance of Dunedin Indoor Sports Venue Trust and the assets it administers.
- 4 Council is both the asset owner and a funder for this organisation and the proposed appointment will serve to strengthen the connection between investment in the asset and the services delivered to the community.
- Mr Meddings has been put forward by Mr Robin Bates Chairperson of Dunedin Indoor Sports Venue Trust as a candidate with the required skill set to assist the Board.
