Strategy Template:

Executive Summary

Scene setting/background, status quo, challenges currently faced

Council's commitment to Sustainability, Treaty of Waitangi and DCC roles

Define key concepts

Define outcomes

Define measures

Define reporting, and DCC reporting in the annual and long term plans

Outline related actions and plans

Define Governance Structure and oversight of the strategy



Suggested process

Councillors and existing Strategy groups will meet to discuss current strategies ie: what works, what doesn't, what improvements are required etc.

Council Workshops for each strategy will be held to discuss feedback which will be populated into the template

Templates will be assessed by strategy groups/Council and areas for further development and engagement identified

Draft refreshed strategies will be presented to Council for approval

Next steps

Council to consider the following

- Should the refresh of each strategy occur in parallel or in a particular sequence?
- What timing should be considered? Eg in line with the 10YP?
- What level of community engagement is preferred for each strategy?
