MINUTE OF THE ENVIRONMENT COURT (16 April 2019)

Introduction

[1] This Minute is issued for the purpose of case management and responds to a number of memoranda that have been filed.

Council memoranda

- [2] The Council has filed a memorandum¹ seeking extension to file three briefs of evidence from Dr Johnson which were due to be filed on Friday 12 April 2019. The Council seeks an extension that they instead be lodged and uploaded to the Council's website by Tuesday 16 April 2019. Given these proceedings are yet to be referred to mediation, I consider an extension of a few days to be reasonable. I will direct the extension as sought.
- [3] The Council has also filed a memorandum² attaching an updated topic table. The Council was directed to advise of any proposed allocations that are in contention. In

summary there is no contention except for the Residential zoning – Dalziel Road topic which I will deal with below.

Residential zoning - Dalziel Road

- [4] I have been referred to three memoranda³ which address the issue of what topic Residential zoning Dalziel Road should be assigned to. The Council had placed it in Topic 2 but RPR Properties have requested it be reassigned to "Group 1: non-strategic".
- [5] Keep Halfway Bush Semi-Rural Incorporated considers that the topic needs to stay in Topic 2 and be heard after the Group 1 strategic appeals, whereas both the Council and RPR Properties argue the topic is not dependant on the outcome of strategic topics so could be advanced to mediation without having to wait for the "Group 1: strategic issues" to be resolved.
- [6] As I am uncertain how to proceed, the matter will be set down for a telephone conference. The appellants Ward and Keep Halfway Bush Semi-Rural Incorporated can clarify whether they are opposing reassignment to Group 1 non-strategic or opposing mediation/hearing of the appeals prior to the determination of the Group 1 strategic appeals. It can expand on its reasoning at the conference.

Withdrawals

- [7] Liquigas has advised⁴ it is withdrawing its interest from University of Otago's appeal (ENV-2018-CHC-270), with all parties consenting and agreeing there is no issue as to costs. This will be noted on the court record.
- [8] Counsel for Mr Parata have filed a memorandum⁵ refining the relief sought in his notice of appeal. Mr Parata has been in communication with the Council regarding this and they confirm there is no issue as to costs. This amendment will also be noted on the court record.


Mergers/changes

- (b) the Ward (ENV-2018-CHC-284) and Keep Halfway Bush Semi-Rural Inc (ENV-2018-CHC-218) appeals will be set down for a telephone conference.
- [12] Leave is reserved for any party to apply for other directions.
