MAY IT PLEASE THE COURT:

1. Liquigas Limited (**Liquigas**) is a section 274 party in relation to this proceeding.
2. Liquigas was interested in the part of the proceedings relating to the relief sought by the Appellant regarding amendments to Objective 5.2.1 in the Network Utilities provisions.
3. Liquigas' concerns in relation to the Network Utilities provisions have been resolved following mediation in relation to the Bulk Fuel Storage provisions. Liquigas therefore gives notice that it withdraws the issue identified and relief sought in its section 274 notice in relation to the Appellant's proposed amendments to Objective 5.2.1.
