STATEMENT OF SIGNIFICANCE

'Melrose House', the former residence of Thomas Glendining, one of the original directors of Ross and Glendining, has historic significance for its association with the notable Glendining family. Melrose House demonstrates design significance as a substantial Edwardian bay villa gentleman's residence designed by prominent architectural partnership Mason and Wales that retains a good level of authenticity and integrity. The c1907 dwelling illustrates the economic prosperity of Dunedin during the late nineteenth and early twentieth centuries that saw the construction of substantial dwellings across the city on the subdivided early estates. However, the large garden setting of the dwelling has been lost following subdivision of the original site in 1977.

Melrose House is comparable to scheduled heritage buildings within Dunedin of a similar type and period. When compared with other scheduled buildings, it meets the threshold to be included on the district plan heritage schedule.

Previous site development

The 'Town of Melrose' was surveyed for Charles Roberts in c.1871. Roberts' 'town' comprised the residential properties lining Merlin and Melrose Streets between Highgate in the north-west and the town belt in the south-east. Roberts' own grand residence, Littlebourne House (demolished in 1949) was on the neighbouring block of the house later built for Thomas Glendining.

House design and construction

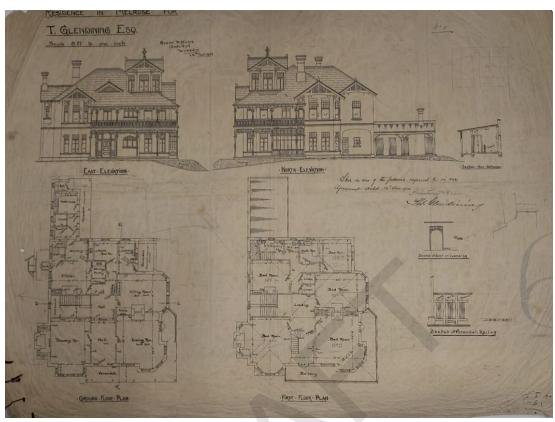
Thomas Glendining acquired a portion of Roberts' Melrose property in May 1905 and appears to have erected a new home for himself and his family by 1908.

Prominent Dunedin architectural partnership Mason and Wales designed Melrose House. The contractors were Armstrong and Moore. Armstrong and Moore were contractors working in Dunedin in the first two decades of the twentieth century. They worked on other Mason and Wales's projects, including the grandstand at the Dunedin Jockey Club (1906 and 1913), a block of shops and warehousing on Stuart Street (1913), the Kensington Drill Hall (1914).

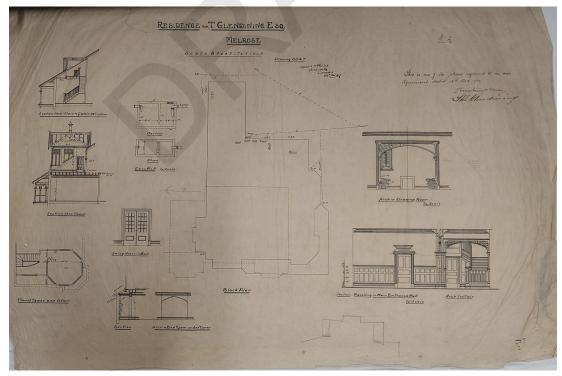
The house is a substantial 'gentleman's residence' — a bay villa of two storeys with a cross-gabled tower room above a return double-height veranda. It is built of brick (now painted) with a Marseilles tile roof with ornamental ridge tiles and finials. The casement windows include 12-light top sashes with coloured glass feature on the principal elevations (double hung sash windows are used at the rear). Decorative timber details feature on the veranda and on the eaves and gable ends. The dwelling demonstrates the transition from established Victorian styles to newer 'Arts and Crafts' styles in the early twentieth century. The overall form and layout of the dwelling maintains earlier characteristics; however, the design and detailing demonstrate aspects of 'Arts and Crafts'.

The dwelling it its original setting, was centrally located on a large site and is elevated above the road. The principal elevation of the dwelling faces east, with the original entry path and stairs connecting the main entry of the dwelling to Melrose Street, at the easternmost corner of the original site. Photographs from 1940s and 1950s show the dwelling prior to the site being subdivided and demonstrates the original setting of the dwelling.

On Glendining's death, the house was sold. The real estate advertisement described it as having a reception hall, lounge, dining, and breakfast rooms, kitchen, maids' rooms, billiard room, four bedrooms, two bathrooms, sunny tower room, and an array of outbuildings.

Later history and development

A brick garage was erected for the Glendinings c. 1917. The property remained in the Glendining family until 1957, when it was transferred to Melrose Nursing Home Ltd. A fire escape was added to the house in c.1959 to meet nursing home requirements and the property was held by the nursing home company until 1971.

In 1977 the property was subdivided to its current extent; photographs below demonstrate the development that has occurred within the original garden of the dwelling. The subdivision and new dwellings have adversely affected the original garden setting of the house.

In 1982 the garage was converted into staff accommodation; ten years later (1992) an addition to the manager's accommodation in the converted garage was erected and connected to the main house by a covered way. Mason and Wales Architects designed alterations and additions to the house in 1989; these involved three internal partitions to create two bedrooms in rooms where there was previously one. Between c.2005 and 2021, the house was run as a bed and breakfast called 'Claremont House Hotel'.

The dwelling itself retains a high degree of architectural integrity, however, the original setting has been lost due to the 1970s subdivision. The external stairs remain extant, however are located within the adjacent property. The dwelling retains its timber window joinery and its decorative features; however, the external brickwork has been painted. It appears metal sheet cladding has been fixed to the upper portion of the gables, possibly concealing the half timbering detail indicated on the Mason and Wales plan.

Notable people/Themes

Ross and Glendining

Ross and Glendining were one of New Zealand's largest manufacturing companies, employing as many as 2,000 people in the 1940s. Company founder John Ross had migrated to Dunedin from Scotland in 1861. He had left school at 14 into a drapery apprenticeship. In Dunedin, he became a partner in Begg Christie & Co. He bought out his partners in 1862 and took Robert Glendining into the partnership. The Glendining family were from Dumfries, Scotland and came from humble origins, their father being employed as an agricultural labourer and then stone cutter. His brothers John and Thomas were also to join the company. 2

Ross and Glendining initially operated Begg, Christie retail store before selling the store to three employees (who traded as Brown, Ewing & Co). Ross and Glendining concentrated on the wholesale trade with new premises on Stafford Street. In 1865, the company decided to give up the retail trade, focusing entirely on the wholesale trade, building a warehouse on Stafford Street – switching from generally drapery to importing and warehousing.³

They financed the building of a woollen mill in 1878 – the Roslyn Mill. In 1883, they built a clothing factory in Stafford Street, expanding nationwide – warehouses in the four main centres, five subbranches, and 15 factories. Post World War Two the company 'languished.' In 1966 the company was taken over by Auckland-

based UEB Industries, which disposed of the warehouses and most of the apparel manufacturing. They sold the Roslyn Mill to Mosgiel Woollens in 1969.⁴

Thomas Glendining (c.1850-1930)

Thomas was the youngest of the Scottish-born Glendining brothers who emigrated to New Zealand. Robert, the best-known, founded Ross and Glendining in the early 1860s.

Thomas arrived in New Zealand four years after Robert, first joined the firm as a junior before gaining experience in his firm Kirkpatrick and Glendining. In 1890, he rejoined Ross and Glendining as warehouse manager. When the firm became a joint stock limited liability company Thomas was one of the original directors, a position he held until his death. He was also a director of the National Insurance Company, the Dominion Rubber Company, and several gold dredging companies. Glendining married Sarah Jane Kelly (died 1919) in 1877 and the couple had five children. Thomas Glendining, who reportedly did not take an active part in civic life, was a keen gardener. The original garden is no longer extant, having been lost by way of subdivision.

Mason and Wales

Andrew Barrie and Julia Gatley's summary of Mason and Wales' architectural practice is reproduced below:

With its origins in the practice formed by William Mason (1810–1897) in Dunedin in 1862, Mason & Wales is New Zealand's oldest architectural practice. Mason had worked in England and Australia before moving to Auckland in 1840, where his outputs included the building now known as Old Government House (1855–1956), and then on to Dunedin in 1862, where the discovery of gold signalled potential. He set up partnership briefly with David Ross (1827–1908) and then, more significantly, with William Clayton (1823–1877). Tasmanian-born Clayton had designed numerous buildings there before immigrating to Dunedin in 1863, again attracted by the gold rush.

Mason & Clayton's key buildings included the Colonial Museum in Wellington (1864–1865), Dunedin's Post Office (1864–1868) and the Otago Provincial Council Buildings (1867). None of these survives.

Mason had been elected to parliament in 1861 and then served as mayor of Dunedin (1865–1867). In semi-retirement, he lived on a North Otago farm from 1867. Meanwhile, Clayton was appointed Colonial Architect in 1869 and moved to Wellington. Mason returned to Dunedin practice in 1871, with Nathaniel YA Wales (1832–1903) as his junior partner. Wales, also English, had immigrated to Dunedin via Melbourne and worked for Mason & Clayton from 1862 as a clerk of works and then as an architect. Mason retired fully in the mid-1870s, and Wales continued the practice.

... Across more than 150 years, the firm's oeuvre has encapsulated the story of New Zealand architecture, most particularly of Dunedin architecture – from colonial-era pluralism and gold rush

exuberance to the gradual embrace of modernism, the adoption of regional inflections, a return to international themes and, now, the response to environmental imperatives.⁵

ASSESSMENT OF HERITAGE SIGNIFICANCE

HISTORIC/SOCIAL

The dwelling has historic value as the former home of Sarah and Thomas Glendining and their family. Thomas was one of the original directors of Ross and Glendining. The house demonstrates the wealth and social standing achieved by members of a notable local family and, more generally, the turn of the twentieth century residential development of Roslyn. The dwelling demonstrates the economic prosperity of Dunedin during the late nineteenth and early twentieth centuries that saw the construction of substantial dwellings across the city. Melrose House was constructed on land subdivided from Charles Roberts 'Melrose' estate. The subject dwelling demonstrates the first generation of development in the fringe townships (now suburbs) following the subdivision of early estates.

The building does not demonstrate heritage values within this criterion.

Melrose House has design significance as a substantial Edwardian gentleman's residence designed by prominent Dunedin architectural practice Mason and Wales, New Zealand's oldest architectural practice. However, the large garden setting of the dwelling has been lost following subdivision of the original site in 1977.

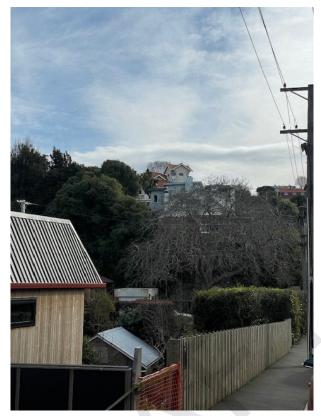
