# STATEMENT OF SIGNIFICANCE

St George Court has overall heritage significance to Dunedin. The building has historic and social significance an inter-war apartment building and design significance as a well-preserved and largely unmodified example of the residential work of local architect Henry McDowell Smith.

St George Court is not comparable to scheduled heritage buildings within Dunedin because this type and period is underrepresented on the schedule. It compares on a national/regional level with recognised similar heritage places.



# Previous site development

Deposit Plan 1547 shows that there was a dwelling on the subject property by 1902.

#### Building design and construction

The building comprises eight flats and six garages; the latter are built to the road boundary. Designed by Henry McDowell Smith for a public company St George Court Ltd, the flats were hailed for their 'high-class' modernity upon completion in March 1937. The flats were designed to fit the terraced site and the building accommodated five, two-bedroom flats and two, three-bedroom ones; one of the three-bedroom flats also boasted a dining room.






McDowell Smith's design responded to the by-law that restricted elements of the design of new flats and to the terraced site. The resulting design was admired for its modernity and the quality of the accommodation. The newspaper article also noted that there was a high demand for flats in the city, with the block was fully let before the tradespeople had finished work.


It was reported when the building was complete that all eight flats had already been leased and most occupied, some before the tradesmen had finished their work. Early residents included newly married couples, widows, and retired couples.





# Later history and development

The flats have been in continual residential use and remain substantially unaltered. New garage doors were fitted in 1965. The building remains in residential use.

#### **Notable people/Themes**

## **Henry McDowell Smith**

Henry McDowell Smith (1887-1965) entered a partnership with Edmund Anscombe in 1913 and then practised in his own right after 1921. McDowell Smith also designed the Tennyson Court Flats in Tennyson Street (1938), St Peter's Anglican Church in Queenstown (1932) and Holy Trinity Anglican Church in Gore (1953-57). There is a scholarship in his name available for architecture students from Otago and Southland to support their studies.

## ASSESSMENT OF HERITAGE SIGNIFICANCE

## HISTORIC/SOCIAL

The building demonstrates heritage values within this criterion. St George Court has historic and social significance as an inter-war apartment building that represents the changing social patterns that prompted the construction of new housing types in the 1920s and 1930s. The flats are also important as they demonstrate the era's growing awareness of domestic economy and efficiency as well as the extent of urban renewal that was taking place in Dunedin at that time.

## SPIRITUAL/CULTURAL

The building does not demonstrate heritage values within this criterion.

#### **DESIGN**

The building demonstrates heritage values within this criterion. St George Court is an example of the residential work of local architect Henry McDowell Smith that retains a high level of exterior authenticity and

integrity. The building is also indicative of the popularity of the Spanish Colonial Revival style for residential architecture between the world wars.

# TECHNOLOGICAL/SCIENTIFIC

The building does not demonstrate heritage values within this criterion.
