Kia ora Mr Mayor,

In response to your query regarding the Northeast Valley and St Clair Bowling Clubs, please find attached a summary of rates relief grants provided over the period from September 2004 to October 2024.

Please note that rates relief grants are currently on hold while the criteria for eligibility are being revised. The DCC will invite applications for rates relief once the updated processes are finalised. All prior recipients will be notified when applications open.

Historically, DCC has not received a high volume of funding applications from sports clubs through the Community Grants programme. However, when applications are submitted, they are typically for equipment purchases. The Community Grant offers a maximum of \$5,000 and is awarded twice annually—in March and September.
