Kia ora Councillor,

Further to your email below.

Earlier this month, while discussing the terms of his mobile trader permit, Mr Hanna advised one of our Environmental Health Officers (EHO) that he had been parking his vehicle and trailer across multiple angled parks in Macandrew Bay. The EHO informed him that this parking method is inconsistent with the angled layout and therefore breaches transport regulations. As a result, it also contravenes the conditions of his mobile trader permit under the Trading in Public Places Bylaw.

While we hadn't received any public complaints to date, the setup put Mr Hanna at risk of breaching his permit conditions or receiving an infringement notice if a complaint is made or if a parking officer is enforcing in the area.

To help resolve this, we've consulted with our Parking Enforcement team, Parks and Recreation, and the Transport team. We've also followed up with a phone call to Mr Hanna to suggest the following options:

- Reverse his trailer into the angled parks and unhitch it, allowing him to comply with the correct parking angle.
- Relocate to a street with parallel parking spaces, where occupying two or parks is permitted.
- Apply for a permit through PARS to park on DCC-owned land, such as the nearby boat club.
- Make a submission to the Transport Regulations team to have the area assessed for improved mobile trader parking options.

Mr Hanna confirmed he has already been in contact with PARS to apply for a permit at the boat club for the next few months and expressed interest in making a submission regarding parking changes in Macandrew Bay. We will follow up with an email to Mr Hanna containing details about this process.
