The information requested is withheld pursuant to sections 7(2)(f)(i) and 7(2)(i) of LGOIMA. Withholding the information is necessary to maintain the effective conduct of public affairs through the free and frank expression of opinions by or to officers in the course of their duty. In addition, withholding the information is necessary to enable the DCC to carry out, without prejudice or disadvantage, negotiations.
