Your request is declined pursuant to section 17(e) of LGOIMA as the information does not exist.

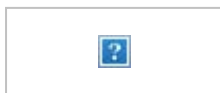

1 APOLOGIES

An apology was received by Cr Syd Brown.

3 ALLOCATION OF PROJECT FUND

The Board noted that it had three projects for consideration for funding and the balance in the fund was \$10,000.

a) Anzac Park Clock Replacement

The Chairperson advised that he had been approached by the Bendigo Trust who were looking for projects in the Mosgiel area to fund. He advised that it was possible they would give the full amount for the restoration or replacement of the clock. However, this would not be known until after the end of the current financial year.

After discussion it was moved (Dillon/Barbour):

"That this matter be revisited in the 2012/13 year pending the outcome of the application to the Bendigo Trust."

Motion carried

b) **Christmas tree Decorations and Picnic Table and Chairs**

Teresa Christie advised that she had received quotes for a variety of options for Christmas Decorations. She also advised that the Mosgiel Business Association was applying for funding from the Bendigo Trust towards this project.

Brian Miller advised that the Blokes Shed was happy to build picnic table and chairs. He suggested that the Board should purchase 6 picnic tables and 4 seats. It was suggested that the seats be placed in the Allanton and Mosgiel East Cemeteries and the tables at Outram, Puddle Alley and Woodside.

It was moved (Barbour/Wilson):

"That the Board allocate \$5000 towards Christmas Decorations, \$4,000 for the purchase of picnic tables and chairs and \$1000 for the installation of the picnic tables and chairs."
