Good morning Tony,

Thank you for your email of 13 January 2015 requesting the date and time a complaint was lodged with the DCC which resulted in the issuing of two Stationary Vehicle Offences (P9674711 and P9674712) on 6 January 2015.

You have informed us that you have already asked informally for the date and time that the complaint had been made, but provision of this information has been declined.

Your request has been considered under the provisions of LGOIMA and the following response is provided.

The information you have requested is refused pursuant to sections 7(2)(a) and 7(2)(c)(i) of LGOIMA. Withholding the information is necessary to protect the privacy of the person making the complaint (section 7(2)(a)). Withholding the information is also necessary, because, if we made the information available to you, then this would be likely to prejudice the supply of similar information, and it is in the public interest that such information should continue to be supplied. (section 7(2)(c)(i)). People who make complaints to the DCC are assured that details of the complaint are kept confidential – without this assurance, many people would be unwilling to lodge complaints.

As we have refused to provide you with information, you have the right, pursuant to section 27 of LGOIMA to have our decision to refuse to provide information, reviewed by the Office of the Ombudsman.
