Thank you for your email.

All your LGOIMA requests are being attended to: - Please would you confirm the following list (four) is complete:

1. [Yaldhurst](#)

1. What is the current total amount owed to Delta in relation to the Yaldhurst Village subdivision project, including interest and any penalty charges, and is that bill continuing to accrue?
2. Can you please provide a breakdown of the total outstanding?
3. Copies of any correspondence, reports, emails, meeting minutes or any other documentation sent, received or held by Delta, Dunedin City Holdings Ltd or the Dunedin City Council (including staff and elected representatives) relating to the Yaldhurst Village development.
4. Copies of any court rulings, findings or other papers relating to the Yaldhurst Development sent to Delta, DCHL or the council.

2. [Travel – Expect next week.](#)

As discussed, I'm happy to refine this request to the following. Let me know if there's still problems.

1. A breakdown listing, for the Mayor and each current councillor, all international and domestic trips taken on council-related business. To be clear, I would like that to cover all trips during their time on council, not just the current term. It would also be useful to get the destinations, or at least the international destinations. I would also like an indication of what the trips were for (where available), or at least the international ones, to provide some context, but can live without it if that's absolutely impossible.
2. The total amount spent by the council on elected representatives' council-related business trips each year since the start of the last term (in 2010).
3. The total number of trips by council staff, and the total cost to council, since 2010.
4. The total spent by council bringing outside parties to Dunedin since 2010.

3. [CST Invoices](#)

Copies of all information released to Bev Butler in relation to requests for invoices from the Carisbrook Stadium Trust since the stadium's completion in 2011.

1(a) If information released to one individual member of the public (Ms Butler) cannot be released for any reason, then alternatively I request all information released publicly under LGOIMA relating to CST invoices, by the CST or DCC, over the same period.

2. Copies of correspondence (email or other) between Bev Butler, the CST and/or

the Dunedin City Council in relation to CST invoices and access to them since the stadium's completion in 2011.

3. Copies of any legal opinions obtained by the DCC in relation to access to information held by the CST since the stadium's completion in 2011.

4. Copies of any and all correspondence (email or other) between the DCC and CST/Farry since the stadium's completion in 2011.

4. Correspondence between DCC CST and other parties relating to CST invoices since May 26

Further to this request, I also request copies of any correspondence between the council, CST and any other parties relating to CST invoices since May 26.

Also, I would like to make the BOLD ASSERTION that once the above LGOIMAs are "caught up", which will happen sooner rather than later, we will comply with the statutory deadlines henceforth.
