Good morning Chris,

Thank you for your email of 17 February 2015 in which you requested information about incidents involving parking wardens.

Your request has been considered under the provisions of LGOIMA and the following response is provided. I have repeated your questions and used your numbering to give context to our response.

Request 1. A breakdown showing how many reported incidents of verbal abuse, physical abuse or both, involving the Dunedin City Council's parking enforcement officers, have been recorded by the council in each of the last five years (or financial years, if easier). I'd like a separate tally for each type of incident (verbal, physical, verbal and physical) if possible.

Request 2. Copies of all reports or descriptions of each incident, with names redacted if necessary to avoid the identification of the parking officers.

Response: The information requested in 1 and 2 above is attached. We have withheld some information in the reports and descriptions of the parking incidents pursuant to section 7(2)(a) of LGOIMA in order to protect the privacy of the parties involved. We have also withheld this information pursuant to section 7(2)(f)(ii) in order to protect parking wardens from improper pressure or harassment.

Request 3. Details of how many of the incidents (if any) involved physical injuries and/or time off work, and for how long in each case.

Response: This information is withheld pursuant to sections 7 (2)(a) and 7(2)(f)(ii) of LGOIMA in order to protect the privacy of DCC officers and to protect officers from improper pressure or harassment.

Request 4. Details of how many of the incidents (if any) resulted in a referral to police and/or police prosecution.

Response: This information is included in the attached information.

We have also redacted some information in the document supplied to you relating to non-work place injuries (for example the first three lines of the last page) which falls outside the scope of your request.

Given we have withheld some information you have the right pursuant to section 27(3) of LGOIMA to have our decision to withhold information reviewed by the Office of the Ombudsman.
