Dear Mr Morris

Thank you for your letter dated 4 May 2015 requesting information about the details of the alleged breach of the Dog Control Act 1996 in relation to your dog Jake.

Your request has been considered under the provisions of both the Local Government Official Information and Meetings Act 1987 (LGOIMA) and the Privacy Act 1993.

I am enclosing the information requested.

I have withheld the name and identifying details of the complainant pursuant to sections 7(2)(a) and 7(2)(c)(i) of LGOIMA. Withholding this information is necessary to protect the complainant's privacy. It is also necessary to withhold the information as making the information available to you would be likely to prejudice the supply of similar information in the future, and it is in the public interest that such information should continue to be supplied.

You will note on the officer's diary pages dated April 11 and April 13, I have redacted information before and after the entries concerning this complaint. This information relates to other work undertaken by the officer and therefore falls outside the ambit of your request.

As we have withheld information, you have the right pursuant to section 27 of LGOIMA to have our decision to withhold information reviewed by the Office of the Ombudsman.

52A FAILURE TO KEEP DOG CONTROLLED OR CONFINED

On Friday 10 April 2015 the Dunedin City Council Animal Services Department received a complaint against your dog a Kerry blue terrier named Jake. Rushing out of your driveway on Sunday 5 April 2015 at 9.30am at member of the public running past 13 McMaster Road and biting him on the left buttock.

As a result of this complaint, and receiving a written statement from a member of the public a \$200.00 infringement notice has been issued for failure to keep dog controlled or confined. Infringement notice is enclosed.

If we receive further complaints of this nature council could classify Jake as a menacing or dangerous dog.

It is important that measures are put in place to ensure your dogs are kept well contained on your property at all times,

The government is determined to see better control of dogs in this country and the legislation and penalties reflect this.

Your fullest co-operation in this very serious matter is sought by the Dunedin City Council Animal Control Department.

Hi DCC Animal Control,

On Sunday 5 April 2015 at around 9:30 am while running up McMaster Road near where the road intersects with

Saddle Hill Road, a dog ran out of Rapid 13 driveway. Dog looked like some sort of terrier or similar, dark grey longish hair, and ran with tail in the air. This dog, after running out of Rapid 13 ran directly in

front of me then ran behind, and immediately bit me on the left buttock. I quickly spun around and the dog took off running down the driveway of Rapid 13.

When I arrived home, 2 photos were taken by my wife; one of my torn shorts caused by dog attack, plus a photo of the dog bite injury.

As of today, (11 April 2015) I still have minor discomfort when sitting.




