Good afternoon Shawn,

Thank you for your email of 4 September requesting

"a copy of all the correspondence about a proposed medical centre to be built on a Green Island car park including all correspondence (including emails) between South Link Health Services, St Margaret's Church and Dunedin City Council."

Your request has been considered under the provisions of the Local Government Official Information and Meetings Act 1987 (LGOIMA).

We ask pursuant to section 10(2) of LGOIMA that you refine your request. As currently worded, Property Officers estimate that it would take approximately four hours to collate information which falls within the ambit of your request. Only after that collation has been completed would we be in a position to make a decision as to whether any, some or all of the information would be made available to you. Given the current number of requests the Dunedin City Council is responding to, and the length of time that responding to this request would take, a response can be provided within three months unless you wish to cover the cost of research in which case a response could be provided within a further 20 working days.

As you are aware the Dunedin City Council's LGOIMA charging policy enables a fee to be charged after three hours of work have been completed. In this instance a fee of \$76.00 per hour would be imposed for work required in excess of three hours.

Please advise whether you wish to refine your request or whether you wish to pay for the information. In refining your request it may be helpful to specify a date range or limit an email recipient by job title. Eg DCC Property Manager.

We also suggest that you direct your enquiry to the other parties named in your email.
