6 October 2015 Dear Sir/Madam: Housing New Zealand Corporation (HNZC) would like to contact the owners Renee Warner of 16 Hislop Street, Liberton regarding an unsafe boundary fence that borders HNZC property at 20 Hislop Street, Liberton Dunedin. We would therefore request the Dunedin Council to provide us with contact details of the owner(s) under Information Privacy Principle 11 of Section 6 of the Privacy Act 1993. The Act allows the Council to disclose personal information to an agency if Council believes there is a reasonable ground that the source of the information is a publicly available publication (Principle 11(b)). And, that non-compliance is necessary for the protection of the public revenue (Principle 11(e) (iii) where HNZC may need to use more

Crown appropriated funds than it is legally obliged to do to erect a fence.
