A civic, business and educational delegation to Shanghai was instigated by the Mayor of Dunedin and supported by the Otago Chamber of Commerce in October 2009. This visit helped shape the upcoming Otago delegation to the World Expo taking place in May 2010, as well as reinforced key relationships, including those with the Shanghai Chamber of Commerce, Shanghai Museum, Shanghai Construction Company, New Zealand government officials and the Shanghai Bureau of Justice.

The delegation was also hosted by Mayor Han Zheng which was a reflection of the high regard placed on the relationship with Dunedin.

### INTRODUCTION

This report outlines the activities and results of a Dunedin delegation to Shanghai in October 2009.

### **BACKGROUND**

The opportunity arose to visit our sister city of Shanghai to investigate opportunities for World Expo 2010 and to support the University of Otago, Otago Polytechnic and the Otago Chamber of Commerce in their business relationships with Shanghai counterparts.

As well as representatives from the Otago Chamber of Commerce, Dunedin City Council, the University of Otago and Otago Polytechnic the delegation was joined by representatives NZ Moray Property. Dunedin City Council was represented by the Mayor and Councillor Chris Staynes, who is both a Councillor and director of Otago Chamber of Commerce.

### **DISCUSSION**

The trip involved a wide range of meetings with individuals and organisations, as outlined in the attached report. Meeting formally with the Mayor of Shanghai was a highlight. Mayor Han Zheng invited Dunedin to send a delegation to visit the World Expo in 2010.

Discussions with a variety of individuals and organisations including the NZ Consul General, Tourism New Zealand Regional Manager, Shanghai Foreign Affairs, and Chairman Liu Yungeng, Chairman of the Standing Committee of the Shanghai People's Congress, highlighted the high regard Dunedin and the sister city relationship is held in within Shanghai. It also helped clarify the potential size, make-up and goals of a delegation to visit the World Expo in 2010.

### **CONCLUSION**

The attached report outlines the outcomes of the visit to Shanghai in October 2009. The trip reinforced the strong links between organisations in Dunedin and Shanghai, and highlighted how best to conduct a delegation to the World Expo in May 2010.



City Council and the Qingdao Bureau of Commerce in September 2013, the following areas are identified and detailed in the Working Mechanism during our discussion for further collaboration:

- Encourage Qingdao University and the University of Otago (Otago Polytechnic as well) to explore opportunities in exchanges and co-operation
- Increase investment opportunities
- Qingdao Deputy Mayor will lead a business delegation to Dunedin in June/July this year. Project China team (John and Ying) will be in touch regarding preparation for business visits
- Encourage personnel exchanges between public sectors in the two cities, including technical experts(particularly in agriculture), scientists, scholars and government officials

Dunedin has strengths in many of these areas. The Qingdao Municipal Government continues to seek expert views and advice on green energy and how to make the region more sustainable. Dunedin definitely has opportunities to explore joint research and collaboration.



### **DUNEDIN PRESENCE IN SHANGHAI**

The key purpose of a Dunedin office in Shanghai is to promote Dunedin education, tourism and business in Shanghai. The Shanghai Foreign Affairs Office (SFAO) is very supportive about this concept.

The SFAO suggests an alternative name to 'Dunedin Representative Office', which may not be approved in Shanghai.

### **EDUCATION**

Dunedin is committed to further innovation and strengthening collaborations between the education institutions in the two cities.

In the last 12 months, we have demonstrated this commitment, especially in tertiary and school students' exchanges. This includes the five schools which signed sister school MoUs in April 2013.

Mr Cull offered two scholarship programmes to Mayor Yang Xiong last year. We had the first group of tertiary students visited Dunedin three weeks ago and now have the school students group visiting Dunedin at the moment. We received overwhelmingly positive feedback regarding students' English classroom experience and business experience.

# SHANGHAI MUNICIPAL FOREIGN AFFAIRS OFFICE

We expressed desire in further education exchanges and confirmed the Scholarship Programme as an annual programme between the cities. We will continue to strengthen school relationships and encourage collaborations/exchanges between tertiary institutions.

### **TECHNOLOGY**

Through the link among Zizhu Hi-tech Industrial Zone Chamber of Commerce, the Otago Chamber of Commerce, the DCC and Research & Enterprise of the University of Otago signed a Relationship Agreement with the Advanced Industrial Technology Research Institute of Jiao Tong University. This is to formalise medical research collaborations and commercialisations between the two universities and companies. This is in addition to the existing MoU between the two universities.

### **TRADE**

We have assisted some Dunedin businesses in trading with Shanghai. Some of them have entered the stage of contract confirmation.

### **CULTURE**

There have been many cultural exchanges between the two cities during the past 12 months, including the museums and the gardens.

### **TOURISM**

We hope to promote tourism industry in both cities. This would generate mutual benefits.

Shanghai Foreign Affairs will discuss and assist with Shanghai Tourism Bureau on future promotion of Dunedin.



### 7 Healthcare

### 7.1 Public Health

Both sides will carry out cooperation and exchange in the areas of disease control, women and children's health as well as health education.

### 7.2 Primary Healthcare

Primary healthcare institutions of the two sides will conduct cooperation and exchange in the family doctor system, community-based healthcare services and healthcare for the elderly.

The forms of cooperation will include reciprocal visits, training programmes, research projects, academic exchanges and seminars.

### 8 Women's Activities

Both cities agree to strengthen the exchange between women's affairs departments and women organizations, and carry out cooperation between women representatives from the political, financial, business, educational, cultural and sports communities in the areas of women's rights, roles and responsibilities.

Shanghai Municipal Foreign Affairs Office and the Office of the Chief Executive of Dunedin City Council will be responsible for administration and coordination of the sister city relationship on behalf of their governments respectively.

This Memorandum is signed in Shanghai on 16 April, 2013, in the English and Chinese languages, both texts being of equal authenticity.

# MEMORANDUM OF UNDERSTANDING ON COOPERATION AND EXCHANGE BETWEEN SHANGHAI AND DUNEDIN 2013-2015

Since Shanghai and Dunedin were twinned in 1994, the two cities have increased mutual understanding and deepened friendship through fruitful cooperation and exchange in the business, trade, public health, educational, recreational and cultural areas. In order to boost the sister city relationship, both cities agree to conduct mutually beneficial cooperation from 2013 to 2015 in the following areas:

### 1 Business and Trade

- 1.1 Both cities agree to continue and encourage exchanges of business delegations.
- 1.2 Both cities agree to continue collaborating to explore mutually beneficial trade and investment opportunities.
- 1.3 Dunedin City Council along with the Otago Chamber of Commerce welcomes Shanghai entrepreneurs who wish to engage in Dunedin business incubator programmes.
- 1.4 The Chamber of International Commerce Shanghai and the Otago Chamber of Commerce agree to increase mutual visits and information sharing to more effectively serve their members.

### 2 Education

- 2.1 Both cities agree to encourage and support educational collaborations between the two cities, including primary, secondary, vocational and tertiary education.
- 2.2 Both cities agree to maintain and strengthen current collaborations in the vocational and tertiary education sectors, including the mutual promotion of languages.
- 2.3 As discussed with Dunedin, five high schools in Shanghai are willing to establish sister school relationship with their counterparts in Dunedin, as part of the efforts to strengthen educational collaborations and exchanges between the two cities.
- 2.4 Shanghai Municipal Education Commission will continue to invite teachers and students from Dunedin to the Shanghai International Sister Cities Youth Camp.

### 3 Tourism

- 3.1 Both cities agree to endeavour to strengthen tourism cooperation, with the aim of increasing tourism flows and strengthening tourism links between the two cities.
- 3.2 Both cities will endeavour to promote cooperation in emerging travel markets such as individual, education and conference activities.

3.3 Both cities agree to collaborate on the status of activities and determine future areas of cooperation in the tourism sector.

### 4 Culture and Sports

### 4.1 Cultural Exchange

Both cities agree to strengthen the long-term relationship between Shanghai Museum and the Otago Museum through on-going exhibition exchanges and staff exchanges. This will extend to various other Shanghai museums, including Shanghai Science and Technology Museum and its branch museum Shanghai Natural History Museum.

Dunedin Public Libraries and Shanghai Library will continue the exchange and cooperate through the Window of Shanghai Project, library forums and exhibitions.

Both cities agree to increase the number of institutions which work together to provide a greater understanding of culture between the two countries.

### 4.2 Sports Exchange

The sports organisations of both cities agree to enhance the exchange of coaches, athletes and officials, from school groups to competitive athletes. Both cities undertake to discuss areas of sporting interest for further development.

### 5 Botany and Horticulture

- 5.1 Both cities agree to maintain the on-going relationship between Dunedin Botanic Garden and Botanical Gardens of Shanghai. This will include the exchange of plant species, information, staff knowledge and expertise, training and professional development.
- 5.2 Both cities agree to mutually grow the beneficial relationship between Lan Yuan and Yu Garden through staff training and exchange, project support and information sharing,

### 6 Law and Justice

- 6.1 Both cities agree to continue law study exchanges between the institutions,
- 6.2 Both cities agree to enhance cooperation in legal services, such as lawyer and notary services.

# 上海市和达尼丁市合作交流备忘录 2013-2015

1994 年,上海市与达尼丁市缔结为友好城市。多年来双方在经济、贸易、公共卫生、教育、娱乐、文化等领域开展了富有成效的合作与交流,促进了相互理解和友谊。为进一步密切双方友城关系,两市同意于2013-2015 年度在以下领域开展互利互惠的合作:

### 一、经济贸易

- (一)双方将继续鼓励经贸代表团互访。
- (二)双方将继续合作,共同发掘互利的贸易和投资机遇。
- (三) 达尼丁市政委员会和奥塔哥商会欢迎上海企业家参与达 尼丁企业孵化基地项目。
- (四)上海国际商会与奥塔哥商会将继续加强代表团互访和信息交流,为两地商会会员提供更有效的经贸服务。

# 二、教育

- (一)双方鼓励和支持在基础、中等、职业和高等教育等领域开展合作交流。
- (二)双方将保持和加强在职业和高等教育领域的现有合作, 推进双方语言在对方城市的推广。
- (三)应达尼丁市方面要求,上海市五所中学愿与达尼丁市五 所中学结为姐妹学校,拓展上海与达尼丁市之间的教育合作与交流。
- (四)上海市教育委员会将继续邀请达尼丁市教师和青少年参加"上海国际友好城市青年夏令营"。

# 三、旅游

- (一)双方将致力于加强旅游方面的合作,以增加游客量并促进两地旅游领域的联系。
- (二)双方将致力于促进在散客、教育和会展等新兴旅游市场方面的合作。
  - (三) 双方将就现有旅游活动开展合作,并确定今后合作的领

域。

### 四、文化和体育

# (一) 文化交流

双方将通过现有的互办展览和人员交流加强上海博物馆和奥塔 哥博物馆的长期友好关系,并将这一合作模式延伸至上海科技馆包 括其分馆上海自然博物馆等上海多个其他的博物馆。

达尼丁公共图书馆与上海图书馆将通过"上海之窗"赠书项目、图书馆论坛以及协助展览继续开展交流与合作。

双方将增加相互交流的文化机构数量,推动两国文化的相互理解。

### (二)体育交流

双方将加强学校团体和专业运动队的教练、运动员和体育官员的交流,并就今后合作的领域进行探讨。

### 五、园林绿化

- (一)双方将通过植物物种交换、信息交流、人员技能和专业知识交流、培训及专业发展等巩固达尼丁植物园和上海的植物园之间现有的合作交流。

# (一)公共卫生

双方公共卫生机构在疾病控制、妇幼保健、健康教育等领域开展交流合作。
