Hi Callum,

Thank you for your email of 8 October 2015 requesting various information.

Your request has been considered under the provisions of the Local Government Official Information and Meetings Act 1987 (LGOIMA) and the following response is provided.

You are requested pursuant to section 10(2) of LGOIMA to refine questions 1 – 3 of your request. As currently worded the requests would take in excess of 3 hours to complete, and as you are aware the DCC LGOIMA policy enables a fee to be charged for work in excess of three hours, and in this case a fee would be charged. If you would like an estimate of the cost to complete your request please contact me. If however you would like to refine your request, it may be easier to discuss refining your request in a telephone conversation.

Request number 4 has been transferred to the New Zealand Police as I believe the information is more closely connected with the functions of the New Zealand Police than with the Dunedin City Council.
