Official information request for BACHOP ESTATE Correspondence

I refer to your official information request dated 30-May-2016 for correspondence between staff regarding the settlement between DCC and the estate of Brent Bachop. I apologise for the delay in providing a response.

In response, Dunedin City Council did not receive a settlement from the estate of Brent Bachop, so staff have checked and found there is no correspondence.

The council had a \$1 million fidelity insurance policy with QBE and received a \$1 million dollar pay-out under that policy. Our insurer QBE then took recovery action against the estate.
