Dear Mr Fairmaid,

**Official information request for information about managers.**

I refer to your official information request dated 9 May 2016. We have extended the due date for your response until today's date as the processing of your request has required the compilation of information, and meeting the original time limit would unreasonably interfere with the operations and priorities of the Council (section 14, Local Government Official Information and Meetings Act 1987).

We provide the answers to your requests under your question below:

1. The number and the titles of all managerial positions, including managers, group managers and general managers.

Dunedin City Council employs 50 managers with various titles. Their names and titles are listed below.

2. Their names and their dates of appointment.

Their names and start dates are listed below.

3. Their qualifications, including academic qualifications, i.e Bachelor, Master or Doctorate degrees, and post-graduate qualifications. And their salaries.

We have decided to refuse your request for information which relates to the qualifications and salaries of managerial staff under section 7(2)(a) of the Local Government Official Information and Meetings Act, as withholding the information is necessary to protect the privacy of those staff.

4. I should be very grateful if you could direct me to the area or areas of your website which contain all these details, or if the website does not do so, supply me with the requested information not so covered.

This information is not currently published on the Dunedin City Council website. As this record is not held by the Council, your request is refused (section 17(e) Local Government Official Information and Meetings Act 1987).
