

I noted that Cadbury hierarchy have decided to close the Dunedin factory that is an iconic firm from what I can gather.

This apparently means that about 360 people will be unemployed.

I did ask the prime Minister today what would be the cost of these people receiving WINZ, some indefinitely, compared with the government assisting these employees (and the council) to take over the management and production of Cadburys, as one group of employees did a while back, somewhere, when their firm closed. I can't remember the details, but they all put in money and had shares in the firm and as they knew the daily routine, they continued their usual work and I am not sure if they hired a manage or one of their managers stepped up.

The point I am making is that it is not impossible for these employees in the Dunedin Cadbury s to do the same, and either the government or your council take over the building and appoint an administrator, rather than lose this iconic firm with the loss of all these jobs, and the tourist attraction that goes with the chocolate museum.

The reason for closure is that shipping the product to Australia is too expensive, so new markets would have to be sourced, and possibly far more emphasis placed on the NZ tourist business, with day chocolate classes for tourists, or even longer courses etc.

As the hierarchy have decided to go, then your council has nothing to lose by obtaining the building and plant and also the right to produce the present products, many of which are iconic to NZ, I believe.

The case it seems is that either Dunedin lies down and dies and lets this firm close, or get up and take it over and keep it going for Dunedin and the employees, because being the 4th largest employer means that many present employees will be unemployed possibly permanently.

Mondelez International Proposes End to Manufacturing Operations in Dunedin in 2018

DUNEDIN, New Zealand – Feb. 16, 2017 – Mondelēz International today briefed its people on a proposal to end manufacturing operations in Dunedin in 2018, with production to move into existing Australian sites.

For more than 80 years, the Dunedin factory has produced *Cadbury* products for consumers in New Zealand and Australia, and the site currently employs 350 people. Over 70 per cent of the products manufactured at the site are exported, with the vast majority being shipped to customers in Australia. If the proposal is adopted, the first phase of redundancies would take place late in 2017, with approximately 100 people remaining with the business until early 2018.

"This is an incredibly difficult announcement, given the factory's proud history and the outstanding performance of our employees," said Amanda Banfield, Area Vice-President for Australia, New Zealand and Japan.

"Our people in Dunedin are amongst the best performing teams in the region and, if it weren't for their dedication and outstanding performance, the factory might have closed some time ago.

"The company's proposal is the result of extensive consideration of the issues affecting local production. We operate in an increasingly competitive industry and the factory's distance from its main market, low volume and complex product portfolio, make it an expensive place to manufacture our products.

"We've been on a multi-year journey reinventing our global supply chain," Mrs Banfield continued. "We're focused on becoming globally cost-competitive through increased production and investment in larger sites, while reducing costs, which allows us to fuel the growth in our brands.

"While the business has absorbed the additional costs associated with Dunedin production for a number of years, there's existing capacity in our Australia sites which can deliver these production volumes at the same quality our consumers expect."

While the proposal would see an end to production in Dunedin, it ensures Mondelēz International maintains a significant and sustainable presence in New Zealand with over 130 people continuing to work in the commercial, finance, and human resources teams across the country.

"New Zealand remains an important market for our business, and if the proposal is adopted, we will continue to invest in those things that make us a valued partner to hundreds of businesses throughout the country," concluded Mrs Banfield.

Mondelēz International has confirmed its intention to support Dunedin's growing tourism sector through an investment in Cadbury World, which already attracts over 110,000 visitors each year. The company is ready to invest in redevelopment work to make Cadbury World an even better visitor experience, however we won't impose it on the community.

The company is confident the exciting plans for redevelopment and the prospect of more visitors and jobs at Cadbury World will appeal to the people of Dunedin. A final decision on the proposed redevelopment will be made by April.

Today marks the beginning of a consultation process with employees and their representatives. If the proposal is adopted, Mondelēz International will provide extensive outplacement and career transition training to enhance employees' opportunities to secure new roles and transition to the next stage in their careers.

The company has also committed to retaining as many of the team as possible and would actively support them in applying for roles that become available in Australia or the region. This support would include relocation assistance for successful applicants and their families.

The Cadbury factory is a historic landmark in the centre of Dunedin, and as such, its future use will be of significant interest to the local community. As part of the consultation process, the Mondelēz International team will engage with interested stakeholders to better understand how the site may be used if the proposal is adopted.

They will not have had to write a CV, or look at what their skills are for a very long time.

It will be devastating for them and daunting as they begin to think about what next, the bills still have to be paid. Anyone who has been made redundant at some stage in their life will know that you go through stages disappointment, anger, 'why me', what do I do now - it's kind of like mourning in a work related way. These folk may very well be thinking they have no skills other than what they currently do on a day to day basis in their current roles.

When I first returned to Dunedin I knew it was extremely unlikely that I'd get a job similar to that I'd worked in. So I went searching for sites that could help me identify my skill base and with a bit of luck might also give some suggest on possible roles/industries I could transfer my existing skills base too.

This site was really useful http://knowyourskills.careers.govt.nz/ and could be used to help the folk at Cadbury identify that they have many more options than they may think. It also a way of capturing data/information i.e. what roles might be suitable that could also assist the Taskforce to reach out to relevant organisations to obtain suitable work or opportunities for these folk.

I also thought we could perhaps put a group of volunteers together who might like to buddy up with or work through an application such as this to help them.

If we do something like this, I'd like to volunteer some of my personal time.

You may have heard today that we have announced a proposal to end operations at our Dunedin factory early in 2018.

Given our proud history making Cadbury chocolate in New Zealand and the significance of our business to the local community, this is incredibly difficult news for those impacted and supporting them is our top priority.

While I won't have any additional news to share at this point in time other than what's outlined below, please let me know if you'd like to catch up and we can arrange a time to do so. I really value our working relationship and am keen to keep communication lines open.

About the announcement

The proposal is the result of careful consideration of the issues impacting local production. We have invested over \$80 million since 2006 to ensure the site is operating as efficiently as possible and our local production team is amongst the best performing in the region across a number of measures.

Despite this, there are some key factors working against Dunedin production in a globally competitive industry. More than 70% of product is exported, the factory is a long way from the main population centres in New Zealand, and the volume produced is low while the product portfolio is complex.

What happens next?

If the proposal is adopted, approximately 350 people will be impacted. The first group of workers will finish at the factory in late 2017, while the remainder will continue with the business until early 2018.

We will now work with our employees, suppliers, unions, government and the broader community to discuss the proposal and ensure their views and concerns are heard and all possible options are considered before a final decision is made. Throughout the process we will ensure we do everything we can to support impacted employees and the local community.

We will continue to have a presence in Dunedin



Mondelez International Proposes End to Manufacturing Operations in Dunedin in 2018

DUNEDIN, New Zealand – Feb. 16, 2017 – Mondelēz International today briefed its people on a proposal to end manufacturing operations in Dunedin in 2018, with production to move into existing Australian sites.

For more than 80 years, the Dunedin factory has produced *Cadbury* products for consumers in New Zealand and Australia, and the site currently employs 350 people. Over 70 per cent of the products manufactured at the site are exported, with the vast majority being shipped to customers in Australia. If the proposal is adopted, the first phase of redundancies would take place late in 2017, with approximately 100 people remaining with the business until early 2018.

"This is an incredibly difficult announcement, given the factory's proud history and the outstanding performance of our employees," said Amanda Banfield, Area Vice-President for Australia, New Zealand and Japan.

"Our people in Dunedin are amongst the best performing teams in the region and, if it weren't for their dedication and outstanding performance, the factory might have closed some time ago.

"The company's proposal is the result of extensive consideration of the issues affecting local production. We operate in an increasingly competitive industry and the factory's distance from its main market, low volume and complex product portfolio, make it an expensive place to manufacture our products.

"We've been on a multi-year journey reinventing our global supply chain," Mrs Banfield continued. "We're focused on becoming globally cost-competitive through increased production and investment in larger sites, while reducing costs, which allows us to fuel the growth in our brands.

"While the business has absorbed the additional costs associated with Dunedin production for a number of years, there's existing capacity in our Australia sites which can deliver these production volumes at the same quality our consumers expect."

While the proposal would see an end to production in Dunedin, it ensures Mondelēz International maintains a significant and sustainable presence in New Zealand with over 130 people continuing to work in the commercial, finance, and human resources teams across the country.

"New Zealand remains an important market for our business, and if the proposal is adopted, we will continue to invest in those things that make us a valued partner to hundreds of businesses throughout the country," concluded Mrs Banfield.

Mondelēz International has confirmed its intention to support Dunedin's growing tourism sector through an investment in Cadbury World, which already attracts over 110,000 visitors each year. The company is ready to invest in redevelopment work to make Cadbury World an even better visitor experience, however we won't impose it on the community.

The company is confident the exciting plans for redevelopment and the prospect of more visitors and jobs at Cadbury World will appeal to the people of Dunedin. A final decision on the proposed redevelopment will be made by April.

Today marks the beginning of a consultation process with employees and their representatives. If the proposal is adopted, Mondelēz International will provide extensive outplacement and career transition training to enhance employees' opportunities to secure new roles and transition to the next stage in their careers.

The company has also committed to retaining as many of the team as possible and would actively support them in applying for roles that become available in Australia or the region. This support would include relocation assistance for successful applicants and their families.

The Cadbury factory is a historic landmark in the centre of Dunedin, and as such, its future use will be of significant interest to the local community. As part of the consultation process, the Mondelez International team will engage with interested stakeholders to better understand how the site may be used if the proposal is adopted.

This apparently means that about 360 people will be unemployed.

I did ask the prime Minister today what would be the cost of these people receiving WINZ, some indefinitely, compared with the government assisting these employees (and the council) to take over the management and production of Cadburys, as one group of employees did a while back , somewhere, when their firm closed. I can't remember the details, but they all put in money and had shares in the firm and as they knew the daily routine, they continued their usual work and I am not sure if they hired a manage or one of their managers stepped up.



Cadbury closure a tragedy for Dunedin and working people

The closure of the iconic Cadbury chocolate factory is a tragedy for Dunedin and local manufacturing, Green Party Co-leader Metiria Turei said today.

Three-hundred and fifty people will lose their jobs as a result of the closure of the Cadbury chocolate factory, which has been in Dunedin since 1884.

"Our hearts go out to the hundreds of people and their families who are facing redundancy today," said Mrs Turei.

"The chocolate factory in Dunedin has survived major economic ups and downs for more than a hundred years, but it hasn't been able to survive a National Government's inaction on manufacturing.

"If elected to Government in September, we will establish a Minister for Manufacturing in Cabinet, to better represent the interests of manufacturers and ensure they thrive.

"Manufacturing has few advocates within this Government. Other sectors, which represent much smaller contributions to the national economy, like Racing, have Ministers fighting for them in Government, while manufacturing does not.

Cadbury closure huge blow to Dunedin

News today that Mondelez intends to close Cadbury's manufacturing plant in Dunedin is a devastating blow for Dunedin, local Labour MPs David Clark and Clare Curran say.

"The loss of 362 jobs is shattering for the people working there and for the city. I have visited the factory many times and appreciated the warm welcome, kind hospitality, and good cheer of the staff," says David Clark.

"These people have been proud to work at this iconic Dunedin institution, and proud to supply products for export with a global recognition. My heart goes out to them."

"These people have expenses to meet and families to feed. It will take time for the news to sink in," says Clare Curran.

"Closures like this affect whole communities. Employment changes affect mortgages and schooling choices. It is too soon to grasp the flow on effects, but we can be certain this will have a huge impact across Dunedin."

"In the year that the manufacturing plant continues to run, it's imperative that central government, civic leaders and the business itself works to ensure all of these workers have the training opportunities they need to find alternative employment," says David Clark.

"One of the key findings of Labour's two year-long future of work commission was that the Government must be an active partner in retraining.

"This closure underscores how absolutely essential effective regional development policy is. Earlier this month Labour launched its CODE regional development initiative for Dunedin. That was warmly received,

but it is only the beginning. It is important that Government works with industry to provide job training and transition opportunities to ensure everyone has a shot at well paid secure work."

"This is shocking news and Labour will be a strong voice for the working people of Cadbury as they face an uncertain future," say the MPs.

Mondelez International Proposes End to Manufacturing Operations in Dunedin in 2018

DUNEDIN, New Zealand – Feb. 16, 2017 – Mondelēz International today briefed its people on a proposal to end manufacturing operations in Dunedin in 2018, with production to move into existing Australian sites.

For more than 80 years, the Dunedin factory has produced *Cadbury* products for consumers in New Zealand and Australia, and the site currently employs 350 people. Over 70 per cent of the products manufactured at the site are exported, with the vast majority being shipped to customers in Australia. If the proposal is adopted, the first phase of redundancies would take place late in 2017, with approximately 100 people remaining with the business until early 2018.

"This is an incredibly difficult announcement, given the factory's proud history and the outstanding performance of our employees," said Amanda Banfield, Area Vice-President for Australia, New Zealand and Japan.

"Our people in Dunedin are amongst the best performing teams in the region and, if it weren't for their dedication and outstanding performance, the factory might have closed some time ago.

"The company's proposal is the result of extensive consideration of the issues affecting local production. We operate in an increasingly competitive industry and the factory's distance from its main market, low volume and complex product portfolio, make it an expensive place to manufacture our products.

"We've been on a multi-year journey reinventing our global supply chain," Mrs Banfield continued. "We're focused on becoming globally cost-competitive through increased production and investment in larger sites, while reducing costs, which allows us to fuel the growth in our brands.

"While the business has absorbed the additional costs associated with Dunedin production for a number of years, there's existing capacity in our Australia sites which can deliver these production volumes at the same quality our consumers expect."

While the proposal would see an end to production in Dunedin, it ensures Mondelēz International maintains a significant and sustainable presence in New Zealand with over 130 people continuing to work in the commercial, finance, and human resources teams across the country.

"New Zealand remains an important market for our business, and if the proposal is adopted, we will continue to invest in those things that make us a valued partner to hundreds of businesses throughout the country," concluded Mrs Banfield.

Mondelēz International has confirmed its intention to support Dunedin's growing tourism sector through an investment in Cadbury World, which already attracts over 110,000 visitors each year. The company is ready to invest in redevelopment work to make Cadbury World an even better visitor experience, however we won't impose it on the community.

The company is confident the exciting plans for redevelopment and the prospect of more visitors and jobs at Cadbury World will appeal to the people of Dunedin. A final decision on the proposed redevelopment will be made by April.

Today marks the beginning of a consultation process with employees and their representatives. If the proposal is adopted, Mondelēz International will provide extensive outplacement and career transition training to enhance employees' opportunities to secure new roles and transition to the next stage in their careers.

The company has also committed to retaining as many of the team as possible and would actively support them in applying for roles that become available in Australia or the region. This support would include relocation assistance for successful applicants and their families.

The Cadbury factory is a historic landmark in the centre of Dunedin, and as such, its future use will be of significant interest to the local community. As part of the consultation process, the Mondelez International team will engage with interested stakeholders to better understand how the site may be used if the proposal is adopted.
