Dear Shani

Thank you for your email of 26 November, requesting information about the number of vehicles in the Council fleet per FTE staff, and the mean and median purchase value of vehicles in the fleet.

In response to your LGOIMA request below, I advise the following:

Council has 111 vehicles in its fleet, made up of 51 cars, 2 buses and 57 trucks, utes or vans. The FTE staff number was 707 at 30 June 2018.

If we take the number of vehicles in the Council fleet as the total of 111, then the vehicles per FTE staff equates to 0.157.

The mean cost price of the 111 vehicles is \$34k. The median value is \$31k.

I trust this answers your query.
