Background:

The Fortune Theatre Trust has recently completed an exhaustive review of its operations to determine the viability or otherwise, of continuing to deliver professional theatre to the Otago/Southland community. The following conclusions were drawn:

- While the current facility remains an outstanding architectural feature within Dunedin city's landscape, it is no longer fit for the purpose of staging the array of productions demanded by 21st century audiences
- Restricted access makes hosting shows and events particularly challenging for the elderly, infirm or disabled
- Working conditions pose potential health hazards that will only worsen over time
- It would be unrealistic to expect the DCC to invest in a refurbishment of this historic venue that, even if completed to a very high level of specification and cost, would still fall short of the flexible performance space required
- The business model currently employed carries an unsustainable level of financial overhead for a single entity to endure
- There is excessive reliance on dwindling levels of grant, donation and sponsorship funding so there is a need to deliver a programme of events capable of significantly increasing audience numbers

Dear Cara Paterson (Community Arts Advisor),

My name is I am a master's student studying New Zealand theatre history here at Otago. Today, I was startled to read about the recent closure of the Fortune Theatre (*). As you may have guessed, I am emailing today to ask if the DCC plans to intervene and save the theatre?
Given our city's plan to brand itself as an arts friendly UNESCO City of Literature, I think it would be a great tragedy to lose the theatre simply because it was not turning a profit. The value of the Fortune is so much more than its capital gain. It functions as a hub for so many of our city's (**) talented performers, directors, technicians, and writers, allowing them to gain valuable professional experience without having to leave the city. I greatly fear what losing the Fortune will do to our lively amateur theatre community. If the theatre closes we risk losing some of our most experienced performers and practitioners to other cities.
If my studies have shown me anything, it is that professional theatre has always struggled with profitability in New Zealand, I am not denying that. Granted, there's only so much putting 'money-in-hand' will do to save the Fortune, especially if their business model is itself inevitably doomed to fail. I do, however, think the DCC ought to take some responsibility in this matter.
If you're not willing to finance the theatre, perhaps the council could temporarily employ someone to help the Fortune renew its model? Maybe the DCC could provide an injection of capital with rolling targets to ensure progress is made?
The bare-minimum, I should think, would be for the yourself or Craig Monk to meet with the Fortune to open a dialogue with the Fortune's Board of Trustees. Beyond that, there's much the council could do to organise fundraising, or community events to help save the theatre. I would very much like to see the DCC show some public support for the theatre. What do you think?
We cannot let this great light be so easily snuffed out. If there's anything I can do, please do let me know. Thank you for taking the time to read through my email.



We've been talking to Creative New Zealand about we can continue to resource professional theatre in Dunedin in a post-Fortune era.

They're committed to keeping the funding they provided the Fortune available for the production and presentation of performing arts in the city.

I am proposing that the DCC do the same.

This year (2017/18) the Grants Subcommittee granted \$95,000. I'm suggesting we commit to ringfencing that money for the planning and provision of professional theatre in Dunedin, for the remaining two years of the triennium.

We can do this two ways: it can be done formally through the council's budget meeting. But if this committee is comfortable with it, we can take care of it ourselves and that won't be necessary.

The mechanism for allocating it will be our next priority, something we will work up with local practitioners when we have confidence in this direction of travel.

We'd like to give as much reassurance to our creative community as we can, as soon as we can.

This e-mail is to advise that Property Services is taking the lead on the Fortune Theatre building and assets within the space. We will also support other parts of Council in the various respects they are involved such as Arts and Culture.

For clarification, please be aware that we are not in any way involved with the future of the Trust or any potential use of Sammys.

Property Services will have a co-ordinating role through the management of the Fortune Theatre building only.

David Bainbridge and I met with the Trust Chair Haley van Leeuwen this morning. Their focus is to realise as many assets as possible in order to pay off their creditors. We are working with the Trust in terms of any interest Council would have in this respect. We have also asked for a set of keys to ensure Council have emergency access to the building.

Just to let everybody know that there is a group from Council that will be inspecting the Fortune Theatre premises on Thursday morning between $9.30 \, \text{a.m.} - 11.00 \, \text{a.m.}$ This will be a standard condition assessment of the building, as well as a review of the assets the Trust may be looking to dispose of, to ascertain whether or not Council would have an interest in purchasing the assets.

This co-ordinated approach will mean the premises can be viewed at one time by Council. If you or any of your teams wish to attend this inspection, please let me know.

For info, the Trust have indicated they will retain the premises until the end of June, though they are having an AGM at the end of May, which may affect their plans.

If there are any other matters that require clarification or advice, please feel free to contact me.



This e-mail is to advise that Property Services is taking the lead on the Fortune Theatre building and assets within the space. We will also support other parts of Council in the various respects they are involved such as Arts and Culture.

For clarification, please be aware that we are not in any way involved with the future of the Trust or any potential use of Sammys.

Property Services will have a co-ordinating role through the management of the Fortune Theatre building only.

David Bainbridge and I met with the Trust Chair Haley van Leeuwen this morning. Their focus is to realise as many assets as possible in order to pay off their creditors. We are working with the Trust in terms of any interest Council would have in this respect. We have also asked for a set of keys to ensure Council have emergency access to the building.

Just to let everybody know that there is a group from Council that will be inspecting the Fortune Theatre premises on Thursday morning between 9.30 a.m. – 11.00 a.m. This will be a standard condition assessment of the building, as well as a review of the assets the Trust may be looking to dispose of, to ascertain whether or not Council would have an interest in purchasing the assets.

Just a quick update on 231 Stuart Street.

The Special General Meeting held on 9 July 2018 resolved that the Fortune Theatre Trust be wound-up and that a liquidator be appointed. The Trust be de-registered and professional advice be sought in relation to the winding up of the Trust, with the Trust undertaking everything to give effect to the winding-up of it.

The building came into the hands of the Liquidators and it has now been fully vacated as at 20 July 2018. A box of keys has been returned and a final set was found that is expected to be returned by the end of the week. There has been some interest in the remaining seating and this will be resolved in due course.

The Council Building Attendants continue to monitor the premises regularly, and compliance checks are continuing.

The leak remains in the building, however the relevant contractor has now been approved and repair work will be undertaken in the near future.

231 Stuart Street is listed as a Strategic Council-Owned Asset in the Significance and Engagement Policy. We may therefore need to consider public consultation in terms of the future of the property.

There is still some Fortune Theatre signage on the building, this is being removed from today.

Just thought I would give you all an update on current matters with the Fortune Theatre building and the Trust since my last update:

The Trust have advised that they wish to vacate the premises on 20 July 2018 and Council has agreed to this.

An auction was held last weekend and was very successful, most of the assets have been sold and only a few items remain within the building. They have just had an offer on the seating so are able to dispose of this as well.

We have had a couple of enquiries about the building, one to lease and one to purchase. In both cases we have responded generally to say that we have noted the interest but are not in a position to confirm anything and that we will advise further when information is to hand.

There is a leak in the roof and when it rains water drips onto the stairs that lead to the control room. We have had this assessed and the solution given is that two of the roof tiles need replaced. Because of the heritage status the tiles will need to be replaced, like for like. There is a contractor available that works on historic buildings such as this and we are working with them to enable them to undertake the work. In the meantime a bucket has been placed on the stairs and Property Services Building Attendant is undertaking a regular check on the building as well as the leak situation.

The Special General Meeting to ratify the dissolution of the Trust as per the previous meeting will be held on Monday 9 July at 5.30 p.m. in the Dunningham Suite, Public Library.

A final farewell of the Fortune will be held for one and a half hours on 15 July by a theatre group. There will also be two board members in attendance at this time. Simon Pickford has been made aware of this as well.

This week's update on Fortune Theatre matters.

As indicated below Task Force Green and Leigh McKenzie have assisted this week in removing rubbish and rummage.

The Trust is to hold an auction of all surplus goods and materials (not including the wardrobe) mid-June to be undertaken by Haywards Auctioneers.

The Wardrobe is to be handled separately and there are groups that are pooling together in an effort to retain the wardrobe for the benefit of the Dunedin community.

The AGM of the Fortune Theatre Trust was held last night and there was quite some discussion about the demise of the Trust and closure of the Fortune Theatre. The meeting resolved that the Trust be dissolved and all the relevant resolutions were passed in this respect. There is to be another meeting between 24 and 48 days' time to confirm the dissolution of the Trust.

Questions from the floor covered a few general points:

- Financial account values.
- Staffing.
- Consultation with the community and potential sponsors.
- The decisions that had been made to try and keep the Trust and Fortune Theatre running.
- There were some questions about the actual Fortune Theatre building itself and Simon Pickford responded
 to these. It was pointed out that the demise of the Trust was not due to the building itself and that these
 two issues needed to be treated separately.
- There were a number of "friends" of the Fortune Theatre Trust who were disgruntled due to the lack of communication and consultation over various matters. There is to be clear communication regarding the holding of the next meeting.

Property Services Building Attendants are starting to monitor the building from end of May as Haley indicated that it is likely to be vacant of people for the majority of the time for the next month.

There is a meeting set down next week among Council staff to think about various options for the building.

An enquiry has been received from a church group wanting to use the building, the person is a friend of Haley's he is having an initial look through the building with Haley this afternoon to check if it is potentially suitable. I advised that any proposal for the building would require specific communication with the Council around this.

The Fortune Theatre is a significant Council asset and there is a requirement in terms of public consultation/liaison/notification in terms of any future proposals because of this.

I hope the above assists in bringing everybody up to date.

This week's update on Fortune Theatre matters.

As indicated below Task Force Green and Leigh McKenzie have assisted this week in removing rubbish and rummage.

The Trust is to hold an auction of all surplus goods and materials (not including the wardrobe) mid-June to be undertaken by Haywards Auctioneers.

The Wardrobe is to be handled separately and there are groups that are pooling together in an effort to retain the wardrobe for the benefit of the Dunedin community.

The AGM of the Fortune Theatre Trust was held last night and there was quite some discussion about the demise of the Trust and closure of the Fortune Theatre. The meeting resolved that the Trust be dissolved and all the relevant resolutions were passed in this respect. There is to be another meeting between 24 and 48 days' time to confirm the dissolution of the Trust.

Questions from the floor covered a few general points:

- Financial account values.
- Staffing.
- Consultation with the community and potential sponsors.
- The decisions that had been made to try and keep the Trust and Fortune Theatre running.
- There were some questions about the actual Fortune Theatre building itself and Simon Pickford responded to these. It was pointed out that the demise of the Trust was not due to the building itself and that these two issues needed to be treated separately.
- There were a number of "friends" of the Fortune Theatre Trust who were disgruntled due to the lack of communication and consultation over various matters. There is to be clear communication regarding the holding of the next meeting.

Property Services Building Attendants are starting to monitor the building from end of May as Haley indicated that it is likely to be vacant of people for the majority of the time for the next month.

There is a meeting set down next week among Council staff to think about various options for the building.

An enquiry has been received from a church group wanting to use the building, the person is a friend of Haley's he is having an initial look through the building with Haley this afternoon to check if it is potentially suitable. I advised that any proposal for the building would require specific communication with the Council around this.

The Fortune Theatre is a significant Council asset and there is a requirement in terms of public consultation/liaison/notification in terms of any future proposals because of this.

I hope the above assists in bringing everybody up to date.
