**Local Government Official Information and Meetings Act 1987 (LGOIMA) Request**

I refer to your e-mail of 9 August and my letter of 6 September relating to your request for the following information:

*I request a breakdown of special and hazardous waste received at the Green Island landfill over the last five years. The breakdown should show for each shipment:*

- The substance.
- Date(s) received (or date range).
- The number of shipments.
- The total amount of material received.
- Where it came from, including the specific customer/project where available.
- The amount paid by the customer.

*I also request a copy of any policy/guidelines for the handling of hazardous waste at the landfill, and any records of breaches of the policy, health and safety incidents or other problems relating to hazardous waste at the landfill during the last five years. This was supplied to you in my e-mail of 6 September 2019.*

I understand you have been in discussion with Chris Henderson (Group Manager Waste and Environmental Solutions). As a result of these discussions I attach a spreadsheet which contains three worksheets relating to the categories of incoming hazardous waste (Hazardous Liquid Wastes, Hazardous Dry Wastes and Contaminated Soils) at the Green Island Landfill. These are collated tables of data which have been exported from the weighbridge control system and recorded by annual weighbridge tonnage against each commercial customer.

Please note that the Council is not the only facility in the city that has the ability to dispose of hazardous waste.

You have asked for detailed information relating to where the waste came from, the project and amount paid by the customer, substance and dates received and number of shipment. In order to provide this information, the Council would be required to undertake substantial research and collation which would interfere with the operation of the Council and therefore pursuant to section 17(f) of LGOIMA your request for this data is declined.

Should you wish to discuss the data that you have received please contact Chris Henderson.

As we have declined to provide some information you are advised that you have the right to seek an appeal by the Office of the Ombudsman
