Thank you for your request for information dated 1 April 2021 regarding Aurora Energy. In response to your questions:

1. How much in dividends before tax have been paid to DCC by Aurora Energy?

Aurora Energy is owned by Dunedin City Holdings Ltd, which is in turn owned by Dunedin City Council. Aurora Energy therefore pays dividends to Dunedin City Holdings Ltd, not directly to Dunedin City Council.
