I want details of total DCC staff numbers broken down into the area they work in; and the staff costs for each area; and also a breakdown of salaries into brackets.

The information is publicly available in the Dunedin City Council Annual Report https://www.dunedin.govt.nz/_data/assets/pdf_file/0010/801676/Annual-Report-2019-20-22-12.pdf. The information can be located in the Council Financial Statements section of the Annual Report with staff pay brackets in part 12 – remuneration and staffing which includes the employee staffing levels as at 30 June 2020 (page 83).

The draft 2021/22 budgets were presented to Council at its 27 January 2021 meeting and are publicly available <https://www.dunedin.govt.nz/council/council-meetings/agendas-and-minutes>. Please note that Council will adopt the draft 10 year plan 2021-2031 at its 30 June 2021 meeting with the agenda being available two working days prior to the meeting.

We are unable to provide DCC staff numbers by department, due to substantial collation. Therefore, pursuant to section 17(f) of LGOIMA we decline to provide this information.
